**AND IN THE MATTER OF THE "County Act":**

**AND IN THE MATTER OF an amendment to Board Order No. 19657, dated the 29th day of October, 1990, annexing certain lands to the City of Camrose.**

**Whereas by Board Order No. 19657, dated the 29th day of October, 1990, certain lands were annexed to the City of Camrose, in the Province of Alberta, and thereupon separated from the County of Camrose No. 22.**

**And whereas it has come to the Board's attention that the detailed description of the territory annexed to the City of Camrose within the aforesaid Board Order No. 19657 is in error.**

**THEREFORE, subject to the Lieutenant Governor in Council approving this Order, or prescribing conditions that the Order is subject to and approving the Order subject to those conditions, or varying the Order and approving the Order as varied, IT IS ORDERED AS FOLLOWS:**

**I. That Board Order No. 19657, dated the 29th day of October, 1990, is hereby amended by deleting the land description contained in Clause I and substituting therefore a new land description as follows:**

**"ALL THAT PORTION OF THE NORTH HALF OF SECTION SIXTEEN (16), TOWNSHIP FORTY-SIX (46), RANGE TWENTY (20), WEST OF THE FOURTH MERIDIAN, WHICH LIES SOUTH AND EAST OF THE SOUTHEASTERLY LIMITS OF THE CANADIAN NATIONAL RAILWAY RIGHT OF WAY AS SHOWN ON PLAN 337 T.R.**

**ALL THAT PORTION OF THE NORTH HALF OF SECTION TWENTY-SIX (26), TOWNSHIP FORTY-SIX (46), RANGE TWENTY (20), WEST OF THE FOURTH MERIDIAN WHICH LIES NORTHERLY AND WESTERLY OF THE**

SOUTHERLY AND EASTERLY LIMITS OF THE MAIN ROAD AND ACCESS ROAD RESPECTIVELY, BOTH AS SHOWN ON ROAD PLAN 882 3091

THAT NORTH SOUTH GOVERNMENT ROAD ALLOWANCE ADJOINING THE WESTERLY BOUNDARY OF THE NORTH WEST QUARTER OF SECTION TWENTY-SIX (26), TOWNSHIP FORTY-SIX (46), RANGE TWENTY (20), WEST OF THE FOURTH MERIDIAN

ALL THAT PORTION OF THE SOUTH WEST QUARTER OF SECTION TWENTY-EIGHT (28), TOWNSHIP FORTY-SIX (46), RANGE TWENTY (20), WEST OF THE FOURTH MERIDIAN, CONTAINED WITHIN ROAD PLAN 882 1680

ALL THAT PORTION OF THE NORTH SOUTH GOVERNMENT ROAD ALLOWANCE ADJOINING THE WESTERLY BOUNDARY OF THE SOUTH WEST QUARTER OF SECTION TWENTY-EIGHT (28), TOWNSHIP FORTY-SIX (46), RANGE TWENTY (20), WEST OF THE FOURTH MERIDIAN WHICH LIES NORTH OF THE PRODUCTION WESTERLY OF THE SOUTHERLY LIMIT OF ROAD PLAN 882 1680

THE NORTH EAST QUARTER OF SECTION TWENTY-NINE (29), TOWNSHIP FORTY-SIX (46), RANGE TWENTY (20), WEST OF THE FOURTH MERIDIAN

THE ABOVE DESCRIBED LANDS CONTAIN ONE HUNDRED AND EIGHTY-SIX AND EIGHTY-FIVE HUNDREDTHS (186.85) HECTARES, (461.71 ACRES), MORE OR LESS."

II. Except as hereby amended Board Order No. 19657 dated the 29th day of October, 1990, be and the same is confirmed.
