
THE IMPROVEMENT DISTRICTS ACT, R.S.A., 1942

CONSTITUTION OF AN IMPROVEMENT DISTRICT, DESIGNATED
IMPROVEMENT DISTRICT No. 11

Edmonton, Tuesday, December 14, 1943.

Whereas the Municipal Districts of Kerr, No. 39, and Castle River, No. 40, have each been merged in part into an enlarged Municipal District; and

Whereas, as a result of such merger, certain unsurveyed lands are no longer included in any Municipal District or Improvement District;

Therefore, His Honour the Lieutenant Governor, by and with the advice of the Executive Council, has been pleased to order (pursuant to the provisions of Section 3 of The Improvement Districts Act, being Chapter 152 of the Revised Statutes of Alberta, 1942), that the following described land, be, and is hereby constituted as an improvement district, and designated as Improvement District No. 11:

All that territory within the Province of Alberta, west and south of a boundary which may be particularly described as follows: Commencing at a point at the intersection of the east boundary of Waterton Lakes and the 49th parallel of Latitude north; thence northerly and following the eastern boundary of Waterton Lakes and Maskinonge Lakes; thence north-easterly and following the Waterton River to its intersection with the southern boundary of Section 20, Township 2, Range 29, west of the Fourth Meridian; thence westerly to the south-west corner of Section 19, Township 2, Range 29, west of the Fourth Meridian; thence northerly on the western boundary of Township 2, Range 29, to the southern boundary of Township 3; thence westerly on the southern boundary of Township 3 to the south-west corner of the south-east quarter of Section 2, Township 3, Range 30; thence northerly to the north-west corner of the north-east quarter of Section 2; thence westerly to the south-west corner of Section 11; thence northerly to the north-west corner of Section 11; thence westerly to the south-west corner of Section 15; thence south-westerly and following the boundary of Waterton Lakes Park and the course of Yarrow Creek and its most easterly tributary to the point where the Park boundary intersects the southern boundary of Township 3, Range 30; thence westerly along the southern boundary of Township 3, projected to the Fifth Meridian; thence northerly along the Fifth Meridian to the south-west corner of Township 4, Range 30, west of the Fourth Meridian; thence westerly along the southern boundary of Township 4 projected to its intersection with the western boundary of Range 1, west of the Fifth Meridian, projected; thence northerly along the said western boundary of Range 1 projected to the southern boundary of Township 5; thence westerly along the southern boundary of Township 5 and its projection to its intersection with the western boundary of Alberta.

Further, that this Order in Council shall be effective as and from January 1st, 1944.
