WHEREAS the Municipal Districts of Woodford No. 550, Morthen No. 551, Pershing No. 581 and Kitchener No. 582 and Improvement Districts Nos. 583 and 612 have been merged either wholly or in part into the Municipal District of Lac St. Anne No. 551, by an Order of the Minister of Municipal Affairs, effective January first, 1944; and

WHEREAS Section 19 of The Municipal District Act provides that, upon the making of an Order, as above mentioned, the Minister shall decide all questions arising over the division or apportionment of the property, rights and the liabilities of the Districts included in whole or in part in the new District;


NOW THEREFORE, the undersigned does hereby appoint SIDNEY VINCENT LEA, Municipal Inspector, to be the person to deal with all matters arising over the division or apportionment of the property, rights and liabilities, or otherwise, of the new District, and of the Districts which have been merged either wholly or in part into the new District; and

THE said SIDNEY VINCENT LEA is further authorized, hereby, to take possession of all the assets of each District so merged either wholly or in part, including the Bank accounts, and to have the same powers with respect to such assets and accounts as if the said Districts still existed, and he were appointed an Administrator of each of them, pursuant to the provisions of the Department of Municipal Affairs Act; and

THE said SIDNEY VINCENT LEA is hereby appointed to be the Administrator of the Municipal District of Lac St. Anne No. 551, and he is empowered hereby to administer the affairs of the said District as from the date of its erection until the date of the assumption of office by the elected council of the District;

THIS ORDER shall be effective as of January first, 1944.

Pursuant to the authority vested in me by Section 19 of The Municipal District Act (being Chapter 151 of the Revised Statutes of Alberta, 1942), I do hereby order:

That the Municipal District of Woodford No. 550, the Municipal District of Morthen No. 551, the Municipal District of Pershing No. 581, the Municipal District of Kitchener No. 582, Improvement District No. 583, as to a part thereof, and Improvement District No. 612, as to a part thereof, be merged into one new Municipal District, to be known and designated as the Municipal District of Lac St. Anne No. 551, and shall on and after this Order becomes effective comprise the following area:

All of Townships 54, 55, 56 and 57, Ranges 1, 2 and 3; Townships 53, 54, 55, 56, 57, 58 and 59; Range 4; all of Township 53, Range 5, excepting thereout those parts of Sections 3, 4, 5 and 6, lying to the south and west of Wabamun Lake; all of Townships 54, 55, 56, 57, 58 and 59, Range 5; That part of Township 53, Range 6, lying north of a line described as follows: commencing at the point of intersection of the eastern boundary of Township 53, Range 6, with the southern boundary of Isle Lake, thence southerly and westerly along the southerly and westerly boundary of Isle Lake to its intersection with the northern boundary of Section 21, thence westerly to the north east corner of Section 20, thence south to the north east corner of Section 8, thence west on the section line to its intersection with the westerly boundary of Township 53, Range 6; that part of Township 54, Range 6, lying east of the Pembina River; all of Townships 55, 56, 57, 58 and 59, Range 6; those parts of Sections 25, 35 and 36 of Township 54, Range 7, lying north and east of the Pembina River; that part of Township 55, Range 7, lying east of the Pembina River; all of Townships 56, 57, 58 and 59, Ranges 7 and 8; all of Townships 56, 57 and 58, Range 9; all of Township 56 and 57, Range 10; all of the above described lands being West of the 5th Meridian.

That the area included by this Order within the above described boundaries of the Municipal District of Lac St. Anne No. 551, shall be, and is divided into seven divisions, for electoral purposes, described as follows:

Division 1: All of Townships 54 and 55, Ranges 1 and 2; the east one-third of Township 54, Range 3; all of Township 55, Range 3; all of the above described lands being West of the Fifth Meridian.

Division 2: The west two-thirds of Township 54, Range 3; all of Townships 53, 54 and the south half of Township 55, Range 4; all of Township 53, Range 5, excepting thereout those parts of Sections 3, 4, 5 and 6, lying to the south and west of Wabamun Lake; all of Township 54, and the south half of Township 55, Range 5; that part of Township 53, Range 6, lying north of a line described as follows: commencing at the point of intersection of the eastern boundary of Township 53, Range 6, with the southern boundary of Isle Lake, thence southerly and westerly along the southern and western boundary of Isle Lake to its intersection with the northern boundary of Section 21, thence westerly to the north east corner of Section 20, thence southerly to the north east corner of Section 8, thence westerly on the section line to the westerly boundary of Township 53, Range 6; that part of Township 54, Range 6, lying east of the Pembina River; those parts of Sections 25, 35 and 36, Township 54, Range 7, lying north and east of the Pembina River; all the above described lands being West of the Fifth Meridian.

Division 3: All of Townships 56 and 57, Ranges 1, 2 and 3; all of the above described lands being West of the Fifth Meridian.

Division 4: The north half of Township 55, Range 4; all of Township 56, Range 4; that part of Township 57, Range 4, lying south of the Pembina River; the north one-half of Township 55, Range 5; all of Township 56, Range 5; that part of Township 57, Range 5, lying south of the Pembina River; all of Townships 55 and 56, Range 6; that part of Township 57, Range 6, lying south of the Pembina River; that part of Townships 55, 56 and 57, Range 7, lying east of the Pembina River; all of the above described lands being West of the Fifth Meridian.

Division 5: That part of Township 57, Ranges 4 and 5, lying north of the Pembina River; the east one-half of Township 57, Range 6, lying north of the Pembina River; all of Townships 58 and 59, Ranges 4 and 5; the east half of Townships 58 and 59, Range 6; all of the above described lands being West of the Fifth Meridian.

Division 6: That part of Township 56, Range 7, lying west of the Pembina River; all of Townships 56, and 57, Ranges 8, 9 and 10; all of the above described lands being West of the Fifth Meridian.

Division 7: That part of the west half of Township 57, Range 6, lying north of the Pembina River; the west half of Townships 58 and 59, Range 6; that part of Township 57, Range 7, lying north of the Pembina River; all of Townships 58 and 59, Ranges 7 and 8; all of Township 58, Range 9; all of the above described lands being West of the Fifth Meridian.

and that the Council of the said Municipal District hereby constituted shall consist of seven members; one councillor to be elected from each of the said divisions, and the candidate with the highest number of votes in each division shall be declared the councillor for that division.

That Tuesday, February 8, 1914, be fixed as the date for receiving nominations for the office of councillor
