

MINISTERIAL ORDER

ERECTION OF THE MUNICIPAL DISTRICT OF MINBURN, No. 453

Pursuant to the authority vested in me by Section 17a, of The Municipal District Act, being Chapter 41 of the Statutes of Alberta, 1926, the undersigned hereby orders:

That the Municipal Districts of Buffalo Coulee, No. 453; Melberta, No. 483; Birch Lake, No. 484, and Lakeview, No. 454,—

be merged into one new Municipal District to be known and designated as the Municipal District of Minburn, No. 453, and shall, on and after the date this Order becomes effective, comprise the following area:

All of Townships 47, 48, 49, 50, 51 and 52, in Ranges 7, 8, 9, 10, 11 and 12, west of the Fourth Meridian.

That the area included by this Order within the above described boundaries of the Municipal District of Minburn, shall be, and are divided into 7 divisions, for electoral purposes, described as follows:

Division 1: All of Townships 47, 48 and 49, in Range 7; the east half of Townships 47, 48 and 49, in Range 8; the south half of Township 50, in Range 7; and Sections 1, 2, 3, 10, 11, 12, 13, 14 and 15, in Township 50, Range 8; all west of the Fourth Meridian;

Division 2: All of Townships 47, 48 and 49, in Range 9; the west half of Townships 47, 48 and 49, in Range 8; the south half of Township 50, in Range 9; and Sections 4, 5, 6, 7, 8, 9, 16, 17 and 18, in Township 50, Range 8; all west of the Fourth Meridian;

Division 3: All of Townships 47, 48 and 49, in Range 10; the east half of Townships 47, 48 and 49, in Range 11; the south half of Township 50, in Range 10; Sections 1, 2, 3, 10, 11, 12, 13, 14 and 15, in Township 50, Range 11; all west of the Fourth Meridian;

Division 4: All of Townships 47, 48 and 49, in Range 12; the west half of Townships 47, 48 and 49, in Range 11; the south half of Township 50, Range 12; Sections 4, 5, 6, 7, 8, 9, 16, 17 and 18, in Township 50, Range 11; all west of the Fourth Meridian;

Division 5: All of Townships 51 and 52, in Ranges 11 and 12; the north half of Township 50, in Ranges 11 and 12; all west of the Fourth Meridian;

Division 6: All of Townships 51 and 52, in Ranges 9 and 10; the north half of Township 50, in Ranges 9 and 10; all west of the Fourth Meridian;

Division 7: All of Townships 51 and 52, in Ranges 7 and 8; the north half of Township 50, in Ranges 7 and 8; all west of the Fourth Meridian,—

and that the Council of the said Municipal District hereby constituted shall consist of 7 members; 1 councillor to be elected from each of the said Divisions, and the candidate with the highest number of votes in each Division shall be declared the councillor for that Division.

That Saturday, the 21st day of February, 1942, be fixed as the date for receiving nominations for the office of councillor for each of the said Divisions, and that the said nominations, and election (if any), shall be in accordance with Subsection (1), Paragraph (c), of Section 197 of the said Act.

That the place for receiving nominations for the office of councillor shall be in the Village Fire Hall in Minburn.

That Dan McLaughlin, of Minburn, be, and he is hereby appointed Returning Officer to conduct the election of one councillor for each Division and who shall at least 7 clear days before nomination day post up a notice in the form set out in the second part of Form "K" in the Schedule to The Municipal District Act in accordance with the provisions of Sections 204 and 205 of the said Act.

That the Returning Officer shall divide the municipality into polling divisions and name a polling place or places therefor and appoint such Deputy Returning Officers and Poll Clerks as are necessary.

That if a poll is required in any division of the said Municipal District it shall be held upon the Saturday following the day of nomination from 9 o'clock a.m. to 5 o'clock p.m.

That Robert Boyd Ritchie, be, and he is hereby appointed to prepare or cause to be prepared a voters' list of the said Municipal District of Minburn in the same manner set out in Section 184 of The Municipal District Act and for such purpose shall have access to the assessment rolls and voters' lists of the Municipal Districts which are in whole or in part merged by this Order into the Municipal District of Minburn and the said Robert Boyd Ritchie shall in compiling or causing to be compiled said voters' list comply as far as possible with the provisions of Sections 185, 186 and 187 of The Municipal District Act and carry out or cause to be carried out all the duties imposed by said Sections upon the Secretary-Treasurer of a Municipal District at the time and in the manner required of a Secretary-Treasurer.

This Order shall become effective on the 30th day of January, 1942.
