The Executive Council has had under consideration the report of the Honourable the Minister of Municipal Affairs, dated September 8th, 1964, stating that:

WHEREAS pursuant to the provisions of section 4 of THE
COUNTY ACT, being chapter 64 of the Revised Statutes of Alberta,
1955, a resolution has been received from the council of the
Municipal District of Minburn, No. 72 and the Board of the Vegreville
School Division No. 19 requesting that the Municipal District of
Minburn, No. 72 and the Vegreville School Division No. 19 be formed
into a County; and

WHEREAS it is considered advisable and expedient to comply with this request:

THEREFORE, upon the recommendation of the Honourable the Minister of Municipal Affairs, the Executive Council advises that the resolution to form a County in this area be and is hereby implemented so that on and after the first day of January, 1965 the County shall be incorporated under the provisions of The County Act and shall be known as the "County of Minburn, No. 27" and shall comprise the lands set out in the schedule hereto; said lands to be divided into seven electoral divisions as set out in the aforementioned schedule.

SCHEDULE

Range 6, in township 46, sections 31 and 32; the west one-third of townships 47 and 48; in township 49, sections 5 to 8 inclusive, 47 to 20 inclusive, 29 and 30.

Range 7, in township 46, the north-east quarter of section 34, sections 35 and 36, in township 47, sections 1 and 2, the east halves of sections 3 and 10, sections 11 to 15 inclusive, the north halves of sections 16 and 17, the north-east quarter of section 18, and sections 19 to 36 inclusive; all of township 48; in township 49, sections 1 to 32 inclusive; the west one-third of townships 50 and 51; in township 52, sections 6, 7, 18, 19 and 30.

Range 8, in township 47, the east half of section 25, the north half of section 34, sections 35 and 36; in township 48, sections 1 to 5 inclusive, the north-east quarter of section 6, and sections 7 to 36 inclusive; all of townships 49, 50 and 51; in township 52, sections 1 to 33 inclusive, the south half and north-west quarter of section 34, and the south-west quarter of section 35.

Range 9, in township 48, the north half and south-east quarter of section 13, the north-east quarter of section 14, the north half of section 18, and sections 19 to 36 inclusive; all of townships 49 to 52 inclusive.

Range 10, in township 48, the east half of section 20, sections 21 to 28 inclusive, the east halves of sections 29 and 32, and sections 33 to 36 inclusive; all of townships 49 to 52 inclusive.

Range 11, in township 49, sections 1, 2, 3, 10 to 15 inclusive, and 19 to 36 inclusive; all of townships 50, 51 and 52; in township 53, sections 1 to 6 inclusive.

Range 12, in township 49, sections 24, 25 and 36; in township 50, sections 1 and 12 to 36 inclusive; all of townships 51 and 52; in township 53, sections 1 to 6 inclusive.

Range 13, the north two-thirds of township 50; all of townships 51 and 52; in township 53, sections 1 to 12 inclusive, and 15 to 22 inclusive.

Range 14, the north two-thirds of township 50; all of townships 51 to 53 inclusive; the south one-third of township 54.

Range 15, in township 51, sections 1 to 4 inclusive, and sections 9 to 36 inclusive; all of townships 52 and 53; the south one-third of township 54.

Range 16, in township 51, sections 13, 14, 23 to 26 inclusive, 35 and 36; the east one-third of township 52.

All of the above described lands lying west of the fourth meridian.

For electoral purposes the County of Minburn No. 27 shall be and is hereby divided into seven divisions described as follows:-

Division No. 1.

Range 6, in township 46, sections 31 and 32; the west one-third of townships 47 and 48; in township 49, sections 5 to 8 inclusive, 17 to 20 inclusive, 29 and 30.

Range 7, in township 46, the north-east quarter of section 34, sections 35 and 36; in township 47, sections 1 and 2, the east halves of sections 3 and 10, sections 11 to 15 inclusive, the north halves of sections 16 and 17, the north-east quarter of section 18, and sections 19 to 36 inclusive; all of township 48; in township 49, sections 1 to 32 inclusive; in township 50, sections 5 to 8 inclusive, 17 to 20 inclusive and 29 to 32 inclusive.

Range 8, in township 47, the east half of section 25, the north half of section 34, sections 35 and 36; the east half of township 48; in township 49, sections 1 to 5 inclusive, 8 to 17 inclusive, 20 to 29 inclusive, and 32 to 36 inclusive; in township 50, sections 1 to 5 inclusive, 8 to 17 inclusive, 20 to 29 inclusive, and 32 to 36 inclusive.

Division No. 2.

Range 8, in township 48, sections 4 and 5, the north-east quarter of section 6, sections 7 to 9 inclusive, 16 to 21 inclusive, and 28 to 33 inclusive; in township 49, sections 6, 7, 18, 19, 30 and 31; in township 50, sections 6, 7, 18 and 19.

Range 9, in township 48, the north half and southeast quarter of section 13, the north-east quarter of section 14, the north half of section 18, and sections 19 to 36 inclusive; all of township 49; the south half of township 50.

Range 10, in township 48, the east half of section 20, sections 21 to 28 inclusive, the east halves of sections 29 and 32, and sections 33 to 36 inclusive; all of township 49; the south half of township 50.

Range 11, in township 49, sections 1, 2, 3, 10 to 15 inclusive, and 19 to 36 inclusive; the south half of township 50.

Range 12, in township 49, sections 24, 25 and 36; in township 50, sections 1, 12, 13 and 14.

Division No. 3.

Range 7, the west one-third of township 51; in township 52, sections 6, 7, 18, 19 and 30.

Range 8, in township 50, sections 30 and 31; all of township 51; in township 52, sections 1 to 33 inclusive, the south half and north-west quarter of section 34, and the south-west quarter of section 35.

Range 9, the north half of township 50; all of townships 51 and 52.

Range 10, in township 50, sections 23 to 26 inclusive, 35 and 36; the east one-third of townships 51 and 52.

Division No. 4.

Range 10, in township 50, sections 19 to 22 inclusive, and 27 to 34 inclusive; the west two-thirds of townships 51 and 52.

Range 11, the north half of township 50; all of town-ships 51 and 52; in township 53, sections 1 to 6 inclusive.

Range 12, in township 50, sections 23 to 26 inclusive, 35 and 36; the east one-third of townships 51 and 52; in township 53, sections 1 and 2.

Division No. 5.

Range 12, in township 50, sections 15 to 22 inclusive, and 27 to 34 inclusive; the west two-thirds of townships 51 and 52; in township 53, sections 3 to 6 inclusive.

Range 13, the north two-thirds of township 50; all of townships 51 and 52; in township 53, sections 1 to 12 inclusive, 15 to 22 inclusive.

Division No. 6.

Range 14, the north two-thirds of township 50; all of township 51; the south half of township 52.

Range 15, in township 51, sections 1 to 4 inclusive, and 9 to 36 inclusive; the south half of township 52.

Range 16, in township 51, sections 13 and 14, 23 to 26 inclusive, 35 and 36; in township 52, sections 1, 2, and 11 to 14 inclusive.

Division No. 7.

Range 14, the north half of township 52; all of township 53; the south one-third of township 54.

Range 15, the north half of township 52; all of town-ship 53; the south one-third of township 54.

Range 16, in township 52, sections 23 to 26 inclusive, 35 and 36.

All of the above described lands lying west of the fourth meridian.
