

# THE COUNTY ACT

---

## THE COUNTY OF VULCAN NO. 2 ESTABLISHED

Edmonton, Wednesday, December 27, 1950.

Whereas, pursuant to the provisions of section 3(2) of The County Act, being chapter 15 of the Statutes of Alberta, 1950, a resolution has

been received from the council of the Municipal District of Vulcan No. 29, that a county be formed in an area which would include the said municipal district; and

Whereas it is considered advisable and expedient to do so;

Therefore, His Honour the Lieutenant Governor, by and with the advice of the Executive Council, has been pleased to order that the resolution to form a county in the area be implemented, the county to be known as The County of Vulcan No. 2, and that the said county be and is hereby established by incorporating therein:

All of the Municipal District of Vulcan No. 29, part of the municipal District of Blackie No. 30, part of the Municipal District of Argyle No. 26, part of the Municipal District of Barons No. 25, part of Special Areas No. 4, and part of Foothills School Division No. 38, part of Macleod School Division No. 28, part of Bow Valley School Division No. 43 and part of Taber School Division No. 6;

so that on and after the 1st day of January, 1951, The County of Vulcan No. 2 shall be comprised of the following lands:

All of township 19, range 19, excepting thereout, sections 1, 2, 3, 4, 9, 10, 11, 12, 13, 14, 15, 16 and the east half of sections 5, 8 and 17;

All of the south half of township 20, range 19, lying south and west of the Bow River;

Sections 5, 6, 7, 8, 18, 19, 30 and 31 and the north half of section 32 and the north-west quarter of section 33, in township 16, range 20;

All of township 17, range 20, excepting thereout, sections 1, 2 and 3 and the east half of section 4;

All of townships 18 and 19 and the south half of township 20 in range 20;

All of sections 29, 30, 31 and 32 and the west half of sections 28 and 33, in township 13, range 21;

All of sections 5, 6, 7, 8, 17, 18, 19, 20, 30 and 31 and the west half of sections 4, 9, 16, 21 and that part of the west half of section 28, lying south of the Little Bow River and that part of sections 29 and 32, lying south and west of the Little Bow River in township 14, range 21;

All of sections 6, 7, 16, 17, 18, 19, 20, 29, 30, 31 and 32 and those parts of sections 5, 8, 9, 10, 15, 21 and 22, lying west of a canal right-of-way as shown upon a Plan of record in the Land Titles Office at Calgary under Irr. No. 164; and those parts of sections 21, 28 and 33, lying west of the easterly boundary of Lake McGregor Reservoir, as shown upon a Plan of record in the said Land Titles Office under Irr. No. 186 in township 15 and all of townships 16, 17, 18, 19 and the south half of township 20, all in range 21;

All of township 13, range 22, excepting thereout sections 1, 2, 5, 6, 11, 12, 13, 14, 23 and 24 and the south-east quarter of section 4 and the south half of section 3, all of townships 14, 15, 16, 17, 18 and 19 and that part of townships 20 and 21 in range 22, lying south and west of the Blackfoot Indian Reserve No. 146;

All of township 13, range 23, excepting thereout sections 1, 2, 3, 4, 5, 6, 7 and 8; all of townships 14, 15, 16, 17, 18, 19 and 20 and that part of township 21, range 23, lying south of the Blackfoot Indian Reserve No. 146.

All of township 13, range 24, excepting thereout sections 1, 2 and 12; all of townships 14, 15, 16, 17, 18 and 19 and the east two-thirds of township 20 and the east two-thirds of township 21, lying south and west of the Blackfoot Indian Reserve in range 24;

All of townships 15, 16, 17 and 18 in range 25;

All of townships 16, 17 and 18 in range 26;

All of the above described lands being west of the fourth meridian;

excepting thereout the land comprising any incorporated Town or Village situated therein.

Further, that no Municipal Hospital District shall be included in the county prior to January 1st, 1952.

Further, that the number of councillors to be elected shall be nine, and that the electoral divisions shall be as follows:

*Division No. 1*

All of sections 29, 30, 31 and 32 and the west half of sections 28 and 33 in township 13, range 21.

All of sections 5, 6, 7, 8, 17, 18, 19, 20, 30 and 31 and the west half of sections 4, 9, 16, 21 and that part of the west half of section 28, lying south of the Little Bow River and that part of sections 29 and 32, lying south and west of the Little Bow River in township 14, range 21.

All of township 13, range 22, excepting thereout sections 1, 2, 5, 6, 11, 12, 13, 14, 23 and 24 and the south-east quarter of section 4 and the south half of section 3.

All of township 14, range 22.

All of township 13, range 23, excepting thereout sections 1, 2, 3, 4, 5, 6, 7 and 8.

All of township 14, range 23.

All of township 13, range 24, excepting thereout sections 1, 2 and 12.

All of township 14, range 24.

All of the above described lands being west of the fourth meridian.

*Division No. 2*

All of sections 6, 7, 16, 17, 18, 19, 20, 29, 30, 31 and 32 and those parts of sections 5, 8, 9, 10, 15, 21 and 22, lying west of a canal right-of-way as shown upon a plan of record in the Land Titles Office at Calgary under Irr. Plan No. 164; and those parts of sections 21, 28 and 33, lying west of the easterly boundary of Lake McGregor Reservoir, all in township 15, range 21.

All that part of township 16, range 21, lying west of the easterly boundary of Lake McGregor Reservoir.

All of township 15, range 22.

All of township 16, range 22.

All of township 15, range 23.

All of township 16, range 23.

All the above described lands being west of the fourth meridian.

*Division No. 3*

All of townships 15 and 16 in range 24.

All of township 15 in range 25.

Sections 1 to 12, inclusive, in township 16, range 25.

All the above described lands being west of the fourth meridian.

*Division No. 4*

All of township 16, range 25, excepting thereout sections 1 to 12 inclusive.

All of township 17, range 25;

All of townships 16 and 17, range 26;

All the above described lands being west of the fourth meridian.

*Division No. 5*

That part of township 17, range 21, lying west of the easterly boundary of Lake McGregor Reservoir.

That part of the south half of township 18, range 21, lying west of the easterly boundary of Lake McGregor Reservoir.

All of township 17 and the south half of township 18 in range 22.

All of township 17 and the south half of township 18, range 23.

All of township 17, range 24.

All the above described lands being west of the fourth meridian.

*Division No. 6*

All of township 19, range 19, excepting thereout sections 1, 2, 3, 4, 9, 10, 11, 12, 13, 14, 15 and 16 and the east halves of sections 5, 8 and 17.

All of the south half of township 20, range 19, lying south and west of the Bow River.

Sections 5, 6, 7, 8, 18, 19, 30, 31 and the north half of section 32 and the north-west quarter of section 33 in township 16, range 20.

All of township 17, range 20, excepting thereout sections 1, 2, 3 and the east half of section 4.

All of townships 18 and 19, range 20.

The south half of township 20, range 20.

Those parts of townships 16, 17 and 18, range 21, lying east and north of the east boundary of Lake McGregor Reservoir as shown on Irr. Plan No. 186.

The east two thirds of township 19, range 21 and the east two thirds of the south half of township 20, range 21.

Those portions of sections 25 and 36 in township 18, range 22, lying east and north of Lake McGregor Reservoir.

All the above described lands being west of the fourth meridian.

*Division No. 7*

That part of the north half of township 18 in range 21 lying west of the easterly boundary of Lake McGregor Reservoir.

The west third of township 19, range 21 and the west third of the south half of township 20, range 21.

The north half of township 18, range 22, excepting thereout those portions of sections 25 and 36 lying east and north of Lake McGregor Reservoir.

All of township 19 and that part of townships 20 and 21, lying south and west of the Blackfoot Indian Reserve in Range 22.

The north half of township 18 and the east halves of townships 19, 20 and that part of the east half of township 21, lying south of the Blackfoot Indian Reserve, all in range 23.

All the above described lands being west of the fourth meridian.

*Division No. 8*

Township 18, in ranges 24, 25 and 26; west of the fourth meridian.

*Division No. 9*

The west halves of townships 19 and 20 and that part of the westerly half of township 21, lying south of the Blackfoot Indian Reserve, all in Range 23.

All of township 19, range 24.

The east two-thirds of township 20 and that part of the east two-thirds of township 21, range 24, lying south and west of the Blackfoot Indian Reserve.

All the above described lands being west of the fourth meridian.

Further, that any arrangement whereby a commitment for which funds have been voted by the Municipal District or School Division has been made, same shall be honoured by the County Council; each teacher who has been appointed by one of the School Divisions named herein to teach in a school which upon the establishment of the county is located within the county shall be thereafter under engagement to the county, and shall be entitled to receive salary at the rate he would have received had the county not been formed and such salary shall continue in effect until such time as a salary schedule applicable to all teachers employed by the county shall have been established according to law.

Further, that at least 50% of the cash which remains to the credit of any one of the Municipal Districts incorporated into the County, after all cash and assets of all the Municipal Districts have been appraised and put in balance, shall be spent by the county in the area in which it was accumulated.
