The Lieutenant Governor in Council orders that

- (a) effective July 1, 2000, the land described in Appendix A and shown on the sketch in Appendix B be separated from Wheatland County and annexed to the Town of Strathmore,

- (b) any taxes owing to Wheatland County at the end of December 31, 2000 in respect of the annexed land are transferred to and become payable to the Town of Strathmore together with any lawful penalties and costs levied in respect of those taxes, and the Town of Strathmore upon collecting those taxes, penalties and costs must pay them to Wheatland County, and
- (c) the assessor for the Town of Strathmore must assess, for the purpose of taxation in 2001, the annexed land and the assessable improvements to it.

PORTION OF LEGAL SUBDIVISION 13 LYING SOUTHWEST OF THE
RAILWAY ON PLAN RY11.

THE SOUTH HALF OF SECTION 12, TOWNSHIP 24, RANGE 25, WEST OF THE
FOURTH MERIDIAN.

ALL THAT PORTION OF THE NORTHWEST QUARTER OF SECTION 12,
TOWNSHIP 24, RANGE 25, WEST OF THE FOURTH MERIDIAN CONTAINED
LYING SOUTH OF ROAD PLAN 8111486.

ALL THAT PORTION OF THE NORTHEAST QUARTER OF SECTION 2,
TOWNSHIP 24, RANGE 25, WEST OF THE FOURTH MERIDIAN CONTAINED
WITHIN PLAN 7710398 AND LYING NORTHEAST OF THE NORTHEASTERLY
BOUNDARY OF SAID PLAN 7710398.

THE SOUTHEAST QUARTER OF SECTION 11, TOWNSHIP 24, RANGE 25,
WEST OF THE FOURTH MERIDIAN.

ALL THAT PORTION OF THE NORTH HALF OF THE SOUTHWEST QUARTER
OF SECTION 11, TOWNSHIP 24, RANGE 25, WEST OF THE FOURTH
MERIDIAN NOT WITHIN THE TOWN OF STRATHMORE, EXCEPTING
THEREOUT ROAD PLAN 9910922.

ALL GOVERNMENT ROAD ALLOWANCES ADJOINING THE WEST
BOUNDARIES OF THE ABOVE DESCRIBED NORTHWEST QUARTER OF
SECTION 1 AND WEST HALF OF SECTION 12, ALL WITH TOWNSHIP 24,
RANGE 25, WEST OF THE FOURTH MERIDIAN.
