





# ORDER IN COUNCIL

Approved and ordered:



Lieutenant Governor

The Lieutenant Governor in Council orders that

(a) effective January 1, 1999, the land described in Appendix A and shown on Appendix B is separated from Wheatland County and annexed to the Town of Strathmore,

(b) any taxes owing to Wheatland County on December 31, 1998 in respect of the annexed land, together with any lawful penalties and costs levied in respect of those taxes, that have not been paid by the date of this Order are transferred to and become payable to the Town of Strathmore, and the Town of Strathmore upon collecting those taxes, penalties or costs must pay them to Wheatland County, and

(c) the assessor for the Town of Strathmore must assess, for the purpose of taxation in 1999, the annexed land and assessable improvements to it.

**ALL THAT PORTION OF THE SOUTH HALF OF SECTION TWENTY-TWO (22), TOWNSHIP TWENTY-FOUR (24), RANGE TWENTY-FIVE (25), WEST OF THE FOURTH MERIDIAN (W4), THAT LIES WEST OF THE CANAL RIGHT OF WAY AS SHOWN ON PLANS I.R.R. 67, I.R.R.380, AND PLAN 8910574; NOT WITHIN THE TOWN OF STRATHMORE;**

**ALL THAT PORTION OF THE NORTHWEST QUARTER OF SECTION FIFTEEN (15), TOWNSHIP TWENTY-FOUR (24), RANGE TWENTY-FIVE (25), WEST OF THE FOURTH MERIDIAN (W4) THAT LIES WEST OF THE CANAL RIGHT OF WAY AS SHOWN ON PLAN I.R.R. 67 AND NORTH AND WEST OF THE RAILWAY RIGHT OF WAY AS SHOWN ON PLAN R.Y. 11;**

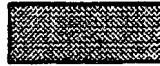

**THAT NORTH SOUTH GOVERNMENT ROAD ALLOWANCE ADJOINING THE WEST BOUNDARY OF THE SOUTH HALF OF SECTION TWENTY-TWO (22), TOWNSHIP TWENTY-FOUR (24), RANGE TWENTY-FIVE (25), WEST OF THE FOURTH MERIDIAN (W4) AND THE WEST BOUNDARY OF THE NORTHWEST QUARTER OF SECTION FIFTEEN (15), TOWNSHIP TWENTY-FOUR (24), RANGE TWENTY-FIVE (25), WEST OF THE FOURTH MERIDIAN (W4) THAT LIES NORTH OF THE PROJECTION NORTH EAST AND SOUTH WEST OF THE NORTHERLY LIMIT OF PLAN R.Y. 11.**
