MUNICIPAL DISTRICT OF BIGHORN NO. 8

DIVISIONAL BOUNDARIES

All of the herein described lands lying west of the fifth meridian.

DIVISION 1

- Range 8 - In township 24, all those portions of sections 30, 31 and 32 lying north of the right bank of the Bow River; all those portions of sections 32 and 33 within the M.D. of Bighorn No. 8 lying south of the right bank of the Bow River.
- In township 25, all that portion of section 4 not included in the Stoney Indian Reserve, sections 5 and 6.
- Range 9 - In township 24, all those portions of sections 17 and 18 lying north of the right bank of the Bow River, all of section 19, all those portions of sections 20 to 25 inclusive lying north of the right bank of the Bow River, sections 26 to 30 inclusive, section 36.
- Range 10 - In township 24, all those portions of sections 13, 14, 22, 23 lying north of the right bank of the Bow River, sections 24 to 26 inclusive, that portion of section 27 not included in the Town of Canmore, all that portion of section 28 lying north of the right bank of the Bow River and not included in the Town of Canmore, that portion of section 34 not included in the Town of Canmore.

DIVISION 2

- Range 9 - In township 23, the northwest quarter of section 31.
- In township 24, sections 6 and 7, the west half of section 8, sections 13 to 16 inclusive, those portions of sections 17 and 18, 20 to 25 inclusive lying south of the right bank of the Bow River.
- Range 10 - In township 24, sections 1 and 2, sections 10 to 12, those portions of sections 13 and 14 lying south of the right bank of the Bow River, sections 15 and 16, section 20, those portions of sections 21 and 22 lying south of the right bank of the Bow River, section 30, those portions of sections 31 and 32 lying south of the right bank of the Bow River and not included in the Town of Canmore.

- In township 25, the north halves of sections 4 and 5, that portion of the north half of section 6 lying east of the right bank of the Bow River, that portion of section 7 lying east and north of the right bank of the Bow River, all sections 8 and 18.

- All of townships 27 to 30 inclusive.

- All that portion of township 31 lying south of the right bank of the Red Deer River.

- In township 25, the north halves of sections 4 and 5, that portion of the north half of section 6 lying east of the right bank of the Bow River, that portion of section 7 lying east and north of the right bank of the Bow River, all sections 8 and 18.

Range 11 - In township 25, all those portions of sections 12 and 13 lying north of the right bank of the Bow River.

DIVISION 3

Range 5 - In township 26, the northwest quarter of section 6 and all of section 7, not included in the Stoney Indian Reserve.

Range 6 - All that portion of township 26 not included in the Stoney Indian Reserve with the exception of that portion of section 24 lying east of the right bank of the Ghost River and all of sections 25 and 36.

- In township 27, sections 2 to 11 inclusive, sections 17 and 18.

Range 7 - All that portion of the east one-third of township 26 not included in the Stoney Indian Reserve.

Range 8 - That portion of township 25 known as the Trans Alta Reservation.

DIVISION 4

Range 6 - All that portion of township 24 lying north of the Rocky Mountain Forest Reserve boundary.

- All that portion of township 25 lying south of the right bank of the Bow River and the south shore of the Ghost Reservoir which is not included in the Stoney Indian Reserve.

- All of township 28.

- All of township 29 with the exception of the east half and northwest quarter of section 24, sections 25, 26, 35 and 36.

- All of township 30.

- In township 31, sections 1 to 12 inclusive, sections 16 to 21 inclusive, sections 28 to 30 inclusive, that portion of section 31 lying south of the right bank of the Red Deer River, sections 32 and 33.

Range 7 - All that portion of township 24 lying north of the Rocky Mountain Forest Reserve boundary and not included in the Stoney Indian Reserve.

- All that portion of the west two-thirds of township 26 not included in the Stoney Indian Reserve.

- All of townships 27 to 30 inclusive.

- All that portion of township 31 lying south of the right bank of the Red Deer River.
