Upon the recommendation of the Honourable the Minister of Municipal Affairs, the Lieutenant Governor in Council, pursuant to section 2(4) of the Municipal District of Bighorn No. 8 Incorporation Act, prescribes the boundaries of the Municipal District of Bighorn No. 8 in accordance with the attached Schedules "A" and "B", effective January 1, 1988.

SCHEDULE "A"

THE MUNICIPAL DISTRICT OF BIGHORN NO. 8

Area as of January 1, 1988

All that parcel or tract of land, situated, lying and being in the Province of Alberta, Canada; and being of Improvement District No. 8 and more -particularly described as follows:

Commencing at the intersection of the easterly boundary of Banff National Park with the right bank of the Bow River, in township twenty-five (25), range eleven (11) west of the fifth (5th) meridian.

Thence southeasterly following the sinuosities of the right bank of the Bow River and the westerly boundary of the Town of Canmore to the intersection of the south boundary of section 31 in township 24, range 10, west of the 5th meridian.

Thence westerly along the south boundary of section 31 to the north west corner of section 30, in said township and range. Thence southerly to the south west corner of said section. Thence easterly to the north west corner of unsurveyed section 20, in said township and range. Then southerly to the southwest corner of unsurveyed section 20. Thence easterly to the northwest corner of unsurveyed section 16 in said township and range. Thence southerly to the southwest corner of unsurveyed section 16. Thence easterly to the northwest corner of unsurveyed section 10 in said township and range. Thence southerly to the southwest corner of unsurveyed section 10. Thence easterly to the northwest corner of section 2 in said township and range. Thence southerly to the southwest corner of section 2. Thence easterly to the northwest corner of section 31 in township 23 range 9 west of the 5th Thence southerly to the southwest corner of the northwest quarter meridian. Thence easterly to the southeast corner of the northwest of said section. quarter in said section. Thence northerly to the northeast corner of the northwest quarter of said section. Thence easterly to the southeast corner of section 6 in township 24, range 9, west of the 5th meridian. Thence northerly to the northeast corner of said section. Thence easterly to southeast corner of the southwest quarter of unsurveyed section 8 in said township and range. Thence northerly to the northeast corner of the northwest quarter of unsurveyed section 8. Thence easterly along the southerly boundary of section 17, 16, 15, 14 and unsurveyed section 13 to the southeast corner of said unsurveyed section 13, in township 24, range 9, west of the 5th meridian.

Thence northerly along the easterly boundary of unsurveyed section 13 and sections 24 and 25 township 24, range 9 west of the 5th meridian to the intersection with the boundary of the Bow Valley Provincial Park as described in Alberta Regulation 54/84. Thence easterly along the boundary of the Bow Valley Provincial Park as described in said Regulation to the intersection with the right bank of the Kananaskis River in section 33 township 24, range 8, west of the 5th meridian.

Thence southerly following the sinuosities of the right bank of the Kananaskis River to the intersection with the southerly boundary of the Stoney Indian Reserve in section 23, township 24, range 8, west of the fifth meridian;

Thence northeasterly along the southerly boundary of the Stoney Indian Reserve to the intersection with the easterly boundary of section 25, township 24, range 8, west of the fifth meridian;

Thence southerly and easterly along the boundary of the Rocky Mountain Forest Reserve as described in provincial documentation in effect at the date of passage of this Order^{$\frac{1}{6}$} In Council to the intersection with the southeast corner of section 1 in township 24, range 6 west of the 5th meridian.

Thence northerly along the east boundary of range 6 to the southwest corner of the northwest guarter of unsurveyed section 6 in township 26, range 5, west of the 5th meridian. Thence easterly to the southeast corner of said quarter. Thence northerly to the northeast corner of said quarter. Thence easterly to the southeast corner of section 7 in said township and range. Thence northerly to the southern limits of the right-of-way of the Canadian Pacific Railway. Thence westerly along the right-of-way of the Canadian Pacific Railway to the intersection of the northerly limits of section 7 in township 26, range 5, west of the 5th meridian. Thence westerly to the northwest corner of unsurveyed section 12 in township 26, range 6, west of the 5th meridian. Thence northerly to the left bank of the Bow River following the sinuosities along and up the right bank of the Ghost River to that point of intersection of that line northerly along the east boundary of unsurveyed sections 23, 26, 35, 2 and 11 to the northeast corner of section 11 in township 27, range 6, west of the 5th meridian. Thence easterly to the east boundary of range 6. Thence northerly along the east boundary of range 6 to the northeast corner of section 13 in township 29, range 6 west of the 5th meridian. Thence westerly to the southeast corner of the southwest quarter of section 24 in said township and range. Thence northerly to the northeast corner of said quarter. Thence westerly to the northwest corner of the said quarter. Thence northerly to the northeast corner of section 23 in said township and range. Thence westerly to the northwest corner of said section.

Thence northerly to the southeast corner of section 3 in township 30, range 6 west of the 5th meridian. Thence easterly to the east boundary of range 6. Thence northerly along the east boundary of range 6 to the northeast corner of section 12 in township 31, range 6 west of the 5th meridian. Thence westerly to the southeast corner of section 16 in said township and range. Thence northerly to the north boundary of township 31, range 6 west of the 5th meridian. Thence westerly to the intersection with the right bank of the Red Deer River. Thence southerly along the right bank of the Red Deer River to the intersection of the east boundary of range 8. Thence southerly along the east boundary of range 8 to the north boundary of township 26. Thence easterly along the north boundary of township 26 to the northwest corner of the northwest guarter of section 31 in township 26, range 7, west of the 5th meridian. Thence southerly to the boundary of the Rocky Mountain Forest Reserve as described in provincial legislation in effect at the date of passage of this Order-In-Council. Thence westerly and southerly and easterly and northerly along the said boundary to the intersection of the east boundary of the Banff National Park. Thence southerly and westerly to the point of commencement.
