APPENDIX A

DETAILED DESCRIPTION OF THE LAND SEPARATED FROM STRATHCONA COUNTY AND ANNEXED TO THE CITY OF FORT SASKATCHEWAN

ALL THAT PORTION OF ROAD PLAN 822-1665 WHICH LIES NORTH OF THE WESTERLY PRODUCTION OF THE NORTH BOUNDARY OF ROAD PLAN 852-1531 AND EAST OF A LINE DRAWN 30 METRES EASTERLY AND PERPENDICULARLY FROM THE WEST BOUNDARY OF ROAD PLAN 822-1665, ALL WITHIN THE FRACTIONAL SOUTHEAST QUARTER OF SECTION TWENTY-FOUR (24), TOWNSHIP FIFTY-FOUR (54), RANGE TWENTY-THREE (23), WEST OF THE FOURTH MERIDIAN, AND WITHIN THE FRACTIONAL NORTHWEST QUARTER OF SECTION NINETEEN (19) AND THE SOUTHWEST QUARTER OF SECTION NINETEEN (19), TOWNSHIP FIFTY-FOUR (54), RANGE TWENTY-TWO (22), WEST OF THE FOURTH MERIDIAN.

IN THE THEORETICAL FRACTION OF THE NORTHEAST QUARTER OF SECTION TWENTY-FOUR (24), TOWNSHIP FIFTY-FOUR (54), RANGE TWENTY-THREE (23) WEST OF THE FOURTH MERIDIAN. SHOWN CONTAINED WITHIN ROAD PLAN 822-1665 AND ADJACENT GOVERNMENT ROAD ALLOWANCE ALONG THE SOUTH BOUNDARY OF PARCEL A, PLAN 374KS AND ROAD PLAN 1794JY, COMMENCING AT A POINT ON THE NORTH BOUNDARY OF THE SAID ROAD ALLOWANCE 288.03 METRES SOUTHWESTERLY FROM THE SOUTHEASTERLY CORNER OF THAT PORTION OF ROAD PLAN 1794JY WHICH LIES WITHIN RIVER LOT NINETEEN (19), FORT SASKATCHEWAN SETTLEMENT THENCE AT A RIGHT ANGLE AND SOUTHEASTERLY FROM THAT POINT ON THE SAID NORTH BOUNDARY OF THE ROAD ALLOWANCE TO A POINT OF INTERSECTION WITH THE WEST BOUNDARY OF THE NORTH-SOUTH GOVERNMENT ROAD ALLOWANCE ON THE EAST SIDE OF THE THEORETICAL FRACTIONAL NORTHEAST QUARTER OF SECTION TWENTY-FOUR (24), TOWNSHIP FIFTY-FOUR (54), RANGE TWENTY-THREE (23), WEST OF THE FOURTH MERIDIAN, THENCE NORTHERLY ALONG AND A PRODUCTION OF THE SAID WEST BOUNDARY OF THE GOVERNMENT ROAD ALLOWANCE ALONG THE SOUTH SIDE OF PARCEL A, PLAN 374ks AND ROAD PLAN 1794JY. THENCE SOUTHWESTERLY ALONG THE SAID NORTH BOUNDARY OF THE GOVERNMENT ROAD ALLOWANCE TO THE POINT OF COMMENCEMENT.

ALL THAT PORTION OF HIGHWAY PLAN 1794JY SHOWN CONTAINED WITHIN RIVERLOT NINETEEN (19), FORT SASKATCHEWAN SETTLEMENT.

ALL GOVERNMENT ROAD ALLOWANCES CONTAINED WITHIN THE ABOVE DESCRIBED LAND.
