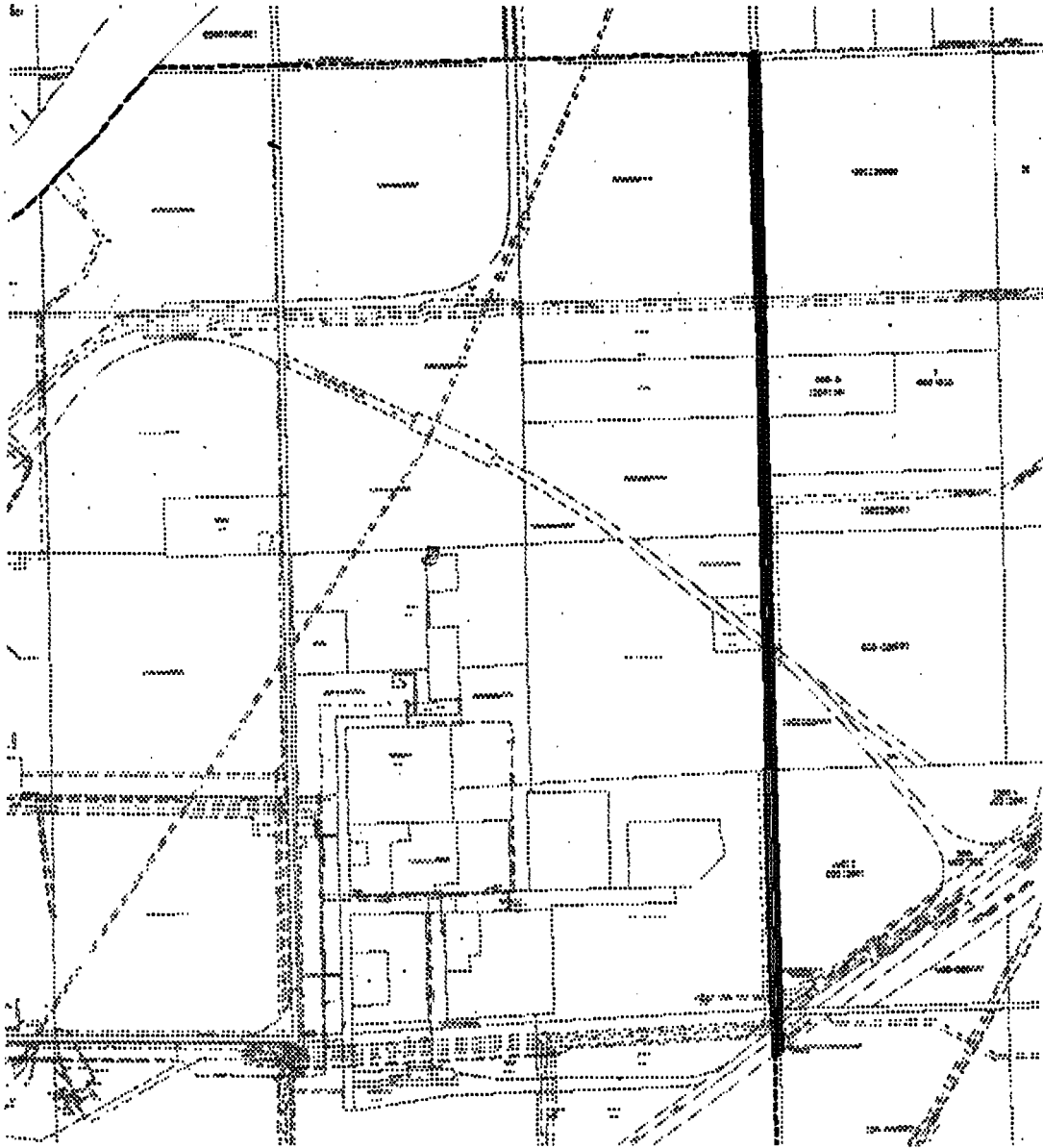

ALL THE GOVERNMENT ROAD ALLOWANCE LYING NORTH OF THE SOUTHERLY BOUNDARY OF ROAD PLAN 3353 JY AND ADJACENT TO THE WEST BOUNDARY OF SECTIONS SEVEN (7), EIGHTEEN (18) AND NINETEEN (19), TOWNSHIP FIFTY-FIVE (55), RANGE TWENTY-ONE (21), WEST OF THE FOURTH MERIDIAN, INCLUDING THE INTERSECTION CONTAINED BY THE NORTHWEST CORNER OF SECTION NINETEEN (19), TOWNSHIP FIFTY-FIVE (55), RANGE TWENTY-ONE (21), WEST OF THE FOURTH MERIDIAN, THE SOUTHWEST CORNER OF SECTION THIRTY (30), TOWNSHIP FIFTY-FIVE (55), RANGE TWENTY-ONE (21), WEST OF THE FOURTH MERIDIAN, THE SOUTHWEST CORNER OF SECTION TWENTY-FIVE (25), TOWNSHIP FIFTY-FIVE (55), RANGE TWENTY-TWO (22), WEST OF THE FOURTH MERIDIAN, AND THE NORTHEAST CORNER OF SECTION TWENTY-FOUR (24), TOWNSHIP FIFTY-FIVE (55), RANGE TWENTY-TWO (22), WEST OF THE FOURTH MERIDIAN.

ALL THAT PORTION OF PLAN 942 3533 DESIGNATED AS ROAD WIDENING WITHIN THE SOUTHEAST QUARTER OF SECTION THIRTEEN (13), TOWNSHIP FIFTY-FIVE (55), RANGE TWENTY-TWO (22), WEST OF THE FOURTH MERIDIAN.
