ORDER IN COUNCIL

The Lieutenant Governor in Council orders that

- (a) effective January 1, 2002, the land described in Appendix A and shown on the sketch in Appendix B is separated from Strathcona County and annexed to the City of Fort Saskatchewan,
- (b) any taxes owing to Strathcona County at the end of December 31, 2001 in respect of the annexed land are transferred to and become payable to the City of Fort Saskatchewan together with any lawful penalties and costs levied in respect of those taxes, and the City of Fort Saskatchewan upon collecting those taxes, penalties or costs must pay them to Strathcona County, and
- (c) the assessor for the City of Fort Saskatchewan must assess, for the purpose of taxation in 2002, the annexed land and the assessable improvements to it.

**DETAILED DESCRIPTION OF THE LANDS SEPARATED
FROM STRATHCONA COUNTY AND ANNEXED TO
THE CITY OF FORT SASKATCHEWAN**

THAT PART OF SECTION TWENTY-FOUR (24), TOWNSHIP FIFTY-FOUR (54), RANGE TWENTY-THREE (23) WEST OF THE FOURTH MERIDIAN LYING OUTSIDE THE CITY OF FORT SASKATCHEWAN EXCEPTING THEREOUT THE MOST SOUTHERLY FORTY (40) METRES OF PERPENDICULAR WIDTH THROUGHOUT THE SAID SECTION.

ALL THAT PORTION OF THE SOUTHWEST QUARTER OF SECTION NINETEEN (19), TOWNSHIP FIFTY-FOUR (54), RANGE TWENTY-TWO (22) WEST OF THE FOURTH MERIDIAN CONTAINED IN ROAD PLAN 822 1665.

THE MOST NORTHERLY FIFTY (50) METRES OF THE NORTHEAST QUARTER OF SECTION THIRTEEN (13), TOWNSHIP FIFTY-FOUR (54), RANGE TWENTY-THREE (23), WEST OF THE FOURTH MERIDIAN CONTAINED IN ROAD PLAN 822 1665.

THE MOST NORTHERLY FIFTY (50) METRES OF THE NORTHWEST QUARTER OF SECTION EIGHTEEN (18), TOWNSHIP FIFTY-FOUR (54), RANGE TWENTY-TWO (22), WEST OF THE FOURTH MERIDIAN CONTAINED IN ROAD PLAN 822 1665.

ALL THAT PORTION OF THE SOUTHWEST QUARTER OF SECTION NINETEEN (19), TOWNSHIP FIFTY-FOUR (54), RANGE TWENTY-TWO (22) WEST OF THE FOURTH MERIDIAN CONTAINED IN ROAD PLAN 852 1531.

THE NORTHEAST QUARTER OF SECTION TWENTY (20), TOWNSHIP FIFTY-FOUR (54), RANGE TWENTY-TWO (22), WEST OF THE FOURTH MERIDIAN.

ALL THAT PORTION OF THE SOUTHEAST QUARTER OF SECTION TWENTY (20), TOWNSHIP FIFTY-FOUR (54), RANGE TWENTY-TWO (22), WEST OF THE FOURTH MERIDIAN LYING NORTHWEST OF THE NORTHWESTERLY LIMIT OF THE DRAINAGE DITCH SHOWN AS PLAN 902 0154.

THE SOUTHWEST QUARTER OF SECTION TWENTY (20), TOWNSHIP FIFTY-FOUR (54), RANGE TWENTY-TWO (22), WEST OF THE FOURTH MERIDIAN.

ALL GOVERNMENT ROAD ALLOWANCES INTERVENING AND ADJOINING THE ABOVE DESCRIBED LANDS EXCEPTING THEREOUT THE NORTH SOUTH GOVERNMENT ROAD ALLOWANCE ADJOINING THE EAST BOUNDARY OF SECTION TWENTY (20), TOWNSHIP FIFTY-FOUR (54), RANGE TWENTY-TWO (22), WEST OF THE FOURTH MERIDIAN.
