Edmonton, October 28, 1997

The Lieutenant Governor in Council orders that

1 effective December 31, 1997, the land described in Appendix A and shown on the sketch in Appendix B is separated from Parkland County and annexed to The Summer Village of Edmonton Beach,

2 effective December 31, 1997, the land described in Appendix C and shown on the sketch in Appendix D is separated from The Summer Village of Edmonton Beach and annexed to Parkland County,

3 any taxes owing to Parkland County on December 31, 1997 in respect of the annexed land described in Appendix A are transferred to and become payable to The Summer Village of Edmonton Beach together with any lawful penalties and costs levied in respect of those taxes, and The Summer Village of Edmonton Beach upon collecting those taxes, penalties or costs must pay them to Parkland County,

4 any taxes owing to The Summer Village of Edmonton Beach on December 31, 1997 in respect of the annexed land described in Appendix C are transferred to and become payable to Parkland County together with any lawful penalties and costs levied in respect of those taxes, and Parkland County upon collecting those taxes, penalties or costs must pay them to The Summer Village of Edmonton Beach,

5 the assessor for The Summer Village of Edmonton Beach must assess, for the purpose of taxation in 1998, the annexed land described in Appendix A and the assessable improvements to it and the assessment must be made on the same basis as the assessment of other property in The Summer Village of Edmonton Beach, and

6 the assessor for Parkland County must assess, for the purpose of taxation in 1998, the annexed land described in Appendix C and the assessable improvements to it and the assessment must be made on the same basis as the assessment of other property in Parkland County

ALL THAT PORTION OF THE NORTH EAST QUARTER OF SECTION NINETEEN (19), TOWNSHIP FIFTY-TWO (52), RANGE ONE (1), WEST OF THE FIFTH MERIDIAN SHOWN AS ROAD ON PLAN 7160 K S WHICH LIES NORTHWEST OF THE NORTHWESTERLY LIMIT OF PLAN 752 1221

ALL THAT PORTION OF THE NORTH WEST QUARTER OF SECTION NINETEEN (19), TOWNSHIP FIFTY-TWO (52), RANGE ONE (1), WEST OF THE FIFTH MERIDIAN WHICH LIES NORTH OF THE NORTHERLY LIMIT OF THE MAIN ROAD AS SHOWN ON PLAN 892 1930 AND NOT WITHIN THE SUMMER VILLAGE OF EDMONTON BEACH

ALL THAT PORTION OF THE NORTH EAST QUARTER OF SECTION TWENTY-FOUR (24), TOWNSHIP FIFTY-TWO (52), RANGE TWO (2), WEST OF THE FIFTH MERIDIAN AND THE GOVERNMENT ROAD ALLOWANCES LYING EASTERLY AND NORTHERLY THEREOF WHICH LIES NORTH EAST OF THE PRODUCTION NORTHWESTERLY OF THE SOUTHWESTERLY BOUNDARY OF LOT 5 MR, PLAN 902 0714 AND EAST OF THE PRODUCTION SOUTH OF THE WEST LIMIT PLAN 762 2044

ALL THAT PORTION OF THE SOUTH EAST TWENTY-FIVE (25), TOWNSHIP FIFTY-TWO (52), RANGE TWO (2), WEST OF THE FIFTH MERIDIAN WHICH LIES EAST OF THE WEST LIMIT AND IT PRODUCTION SOUTHERLY OF PLAN 762 2044 AND SOUTH OF THE PRODUCTION WEST OF THE NORTH LIMIT OF PLAN 323 A P.
