The Hon. the Attorney General reports, under date of September 13th. 1911, that he has had under consideration the petition of the Council of the Village of Athabasca Landing, for the erection of the said village into a town municipality under the provisions of the Municipal Amendment Ordinance. 1901;

AND WHEREAS satisfactory proof of the preliminary acts and requirements requisite to the erection of the said village into a town has been furnished;

Upon the recommendation, therefore, of the Hon. the Attorney General. the Executive Council advise that Your Honour's Proclamation do issue, proclaiming that on and after the 19th day of September. 1911. the said Village of Athabasca Landing be erected into a Town Municipality in accordance with the said Ordinance. to be known as the Town of Athabasca Landing. and that the area of the said Town of Athabasca Landing consist of the following lands: The Hudson's Bay Company's Reserve, River Lots One, Two and Three West, River Lots One and Two East, all of Sections Twenty and Twenty-one, lying North of the Athabasca River, and all of Sections Sixteen, Seventeen, Twenty and Twenty-one, lying South of the Athabasca River, all

in Township sixty-six, in Range twenty-two, West of the Fourth Meridian, together with all road allowances and public roads lying within or adjoining the above described lands;

Upon the further recommendation of the Hon. the Attorney General, the Executive Council advise that C. E. Nancekivill, of Athabasca Landing, Alberta, be named as the Returning Officer for the holding of the first election of Mayor and Councillors for the said town.
