Upon the application of the Council of the Town of Barrhead, in the Province of Alberta; upon reading the consent of the Director of Town and Rural Planning and of the Assistant Director surveys for this Province; upon reading the consent of the Municipal District of Barrhead No. 106; upon reading the consents of the owners of the properties, upon reading the other material filed:

It is ordered that the land hereinafter described be detached from the Municipal District of Barrhead No. 106 and be annexed to the Town of Barrhead

Firstly All of the land subdivided under Plan 6086 H W containing 3 68 acres more or less (S E 29-59-3-5)

Secondly All that portion of the original road allowance adjoining the south boundary of the south-east quarter of section 29, township 59, range 3, west of the fifth meridian, in the Province of Alberta, which lies between the production southerly of the east and west boundaries of the land subdivided under the said Plan 6086 H W Containing 0 45 of an acre more or less

the lands hereby firstly described containing 21 64 acres, more or
less, reserving thereout all mines and minerals,

Secondly All that portion of the original Road Allowance adjoining the
south boundary of the said south-west quarter of section 28 which
lies between the production southerly of the west boundary of the
land subdivided under Plan 1792 H W and the production southerly
of the east boundary of the said quarter section, containing 1 87
acres, more or less, reserving thereout all mines and minerals;

And upon reading the resolution passed by the Town Council in support of the application

And upon hearing the representations made by the Municipal District of Barrhead No. 106 at the said public hearing, and upon reading the other material filed:

It is ordered that the lands hereinafter described be detached from the Municipal District of Barrhead No. 106 and that the same be and they are hereby annexed to the Town of Barrhead.

Firstly

Lot "A" being a subdivision of part of the south-east quarter of section 20, township 59, range 3, west of the fifth meridian, in the townsite of Barrhead according to a plan of record in the Land Titles Office for the North Alberta Land Registration District as 4054 H W Containing 35 32 acres, more or less

Reserving thereout of the above firstly described lands all mines and minerals

Secondly

All that portion of the original road allowance which adjoins the east boundary of the said Lot "A" being the road allowance adjacent to the east boundary of the south-east quarter of section 20, township 59, range 3, west of the fifth meridian
