And upon reading the material filed; and it appearing that there is a need for the annexation of the area to the Town and that none of the land) owners object to the annexation thereof and that the consent of the County of Barrhead No. 11 to the separation of the area from the County has been obtained and that the Director of Town and Rural Planning has no objection to the area being annexed to the Town:

It is ordered that the following described lands be annexed to the Town of Barrhead as of December 30th, 1959, namely.

Firstly All of the land subdivided under Plan 680 K.S containing 5 03 acres more or less

Secondly All of the land subdivided under Plan 1540 KS containing 2 18 acres more or less

Thirdly All of the land described in Certificate of Title 77-U-175 as follows.

All that portion of the south-west quarter of section 28, town-ship 59, range 3, west of the fifth meridian, in the Province of Alberta, described as follows:

Commencing at the north-west corner of the land subdivided under Plan 3414 H W, thence along the production northerly of the west boundary of the said subdivision to a point 1320 01 feet northerly from the south boundary of the said quarter section measured along the said production and the said west boundary and the west boundary of the land subdivided under Plan 1792 HW, thence easterly and parallel to the said south boundary to a point on the east boundary of the said quarter section, thence southerly along the said east boundary to the north-east corner of the land subdivided under Plan 4540 KS, thence westerly along the north boundary of the subdivision shown on the said Plan 4540 KS to the east boundary of the land subdivided under the said Plan 1792 H W, thence northerly along the said east boundary and along the east boundary of the subdivision shown on the said Plan 3414 HW, to the northeast corner thereof, thence westerly along the north boundary of the subdivision shown on the said Plan 3414 HW to the point of commencement
