Whereas by Board Order No 12383, dated the 31st day of October, 1979, certain lands were annexed to the Town of Beaverlodge and thereupon separated from the County of Grande Prairie No. 1;

And whereas it has come to the attention of the board that the detailed description of the territory annexed to the Town of Beaverlodge attached to the aforesaid Order No. 12383, as Schedule "C", is in error.

Therefore, subject to the Lieutenant Governor in Council approving this order, or prescribing conditions that this order is subject to and approving the order subject to those conditions, or varying the order and approving the order as varied, it is ordered that Board Order No. 12383, dated the 31st day of October, 1979, is hereby amended by deleting Schedule "C" attached thereto and substituting therefor a new Schedule "C" attached hereto.

Except as hereby amended, Board Order No 12383, dated the 31st day of October, 1979, be and the same is confirmed.

SCHEDULE "C"

A DETAILED DESCRIPTION OF TERRITORY
ANNEXED TO THE TOWN OF BEAVERLODGE
IN THE PROVINCE OF ALBERTA

All that portion of the north-east quarter of section 35, township 71, range 10, west of the sixth meridian lying north easterly of the north easterly limit of the road as shown on road plan 2973 J Y and its production north westerly throughout

All that portion of the south-west quarter of section 1, township 72, range 10, west of the sixth meridian described as follows

Commencing at the south-west corner of the said quarter section, thence northerly along the west boundary of the said quarter section a distance of 438 feet, thence easterly and parallel to the south boundary of the said quarter section a distance of 198 feet, thence southerly and parallel to the said west boundary a distance of 268 feet, thence westerly and parallel to the said south boundary a distance of 60 feet, thence southerly and parallel to the said west boundary a distance of 170 feet to the said south boundary, thence westerly along the said south boundary to the point of commencement

The most southerly 438 feet of the north-south government road allowance adjoining the west boundary of the south-west quarter of section 1, township 72 range 10, west of the sixth meridian

All that portion of the south-east quarter of section 2, township 72, range 10, west of the sixth meridian not within the Town of Beaverlodge

The east half of the east half of section 3, township 72, range 10, west of the sixth meridian Excepting thereout road plan 2973 J Y and railway plan 1209 E O

The south-east quarter of section 10, township 72, range 10, west of the sixth meridian described as follows

- (a) all that portion which lies north easterly of the north easterly limit of road plan 2973 J Y and not within the Town of Beaverlodge,
- (b) all that portion of the east half of the said south-east quarter contained in road plan 4082 E O

All that portion of the south-west quarter of section 11, township 72, range 10, west of the sixth meridian, not within the Town of Beaverlodge

All that portion of the north-south government road allowance adjoining the west boundary of the south-west quarter of section 11, township 72 range 10, west of the sixth meridian, not within the Town of Beaverlodge
