And in the matter of an applica-
tion by the Town of Beaverlodge
for the annexation of certain
territory adjacent to the Town.

Upon application of the Town of Beaverlodge, in the Province of Alberta, for an Order to include within the said Town certain territory adjacent thereto, upon reading the consent of the County of Grande Prairie No. 1, upon reading the consent of the Department of Highways and upon reading the other material filed:

It is ordered that the lands hereinafter described be detached from the County of Grande Prairie No. 1 and that the same be and are hereby annexed to the Town of Beaverlodge:

All that portion of the south-east quarter of section 11, township 72, range 10, west of the sixth meridian in the said Province subdivided under Plan 2695 N Y

Excepting thereout that portion of the said land formerly part of lot 2, Plan 5314 H W now within the limits of the said town

That any taxes owing to the County of Grande Prairie as at the 31st day of December, 1965 in respect of the aforementioned property shall transfer to and become payable to the Town of Beaverlodge, together with the amount of any lawful penalties and costs levied thereon in respect of such taxes, however, upon the Town of Beaverlodge collecting any or all of the said taxes and lawful penalties and costs levied thereon, in respect of the said property, such collections shall forthwith be paid by the said town to the said county

And it is further ordered that for taxation purposes commencing in the year 1966, the assessor for the Town of Beaverlodge shall re-assess the lands and assessable improvements thereon which were by this order annexed to it, so that the assessment thereof shall be fair and equitable with other related lands and assessable improvements in the town

It is further ordered that the Chief Provincial Assessor appointed pursuant to the provisions of The Municipalities Assessment and Equalization Act, shall for taxation or grant purposes commencing in the year 1966, reassess or revalue, as the case may be all properties that are assessable or subject to valuation under the terms of The Electric Power and Pipe Line Assessment Act and The Municipal and Provincial Properties Valuation Act, within the areas by this order annexed to the Town of Beaverlodge so that the assessment or valuation shall be fair and equitable with properties of a similar nature

This order shall take effect as, on and from the 1st day of January, 1966.
