APPENDIX A

DETAILED DESCRIPTION OF THE LANDS SEPARATED FROM LACOMBE COUNTY AND ANNEXED TO THE TOWN OF BLACKFALDS

ALL THAT PORTION OF THE NORTHWEST QUARTER OF SECTION TWENTY-SIX (26), TOWNSHIP THIRTY-NINE (39), RANGE TWENTY-SEVEN (27) WEST OF THE FOURTH MERIDIAN LYING EAST OF THE MOST WESTERLY RIGHT-OF-WAY BOUNDARY OF ROAD PLAN 4011EU, EXCEPTING THEREOUT:

- 1) LOT H, PLAN 6174MC
- 2) THAT PORTION OF HIGHWAY STREET LYING WEST OF LOT H, PLAN 6174MC AND BETWEEN ROAD PLAN 705EO AND ROAD PLAN 4011EU
- 3) ALL THOSE PORTIONS OF ROAD PLANS 705EO, 012 2084, AND 4011EU LYING NORTH OF A LINE DESCRIBED AS FOLLOWS:

STARTING AT THE POINT WHERE THE BOUNDARY OF 012 2084 INTERSECTS WITH THE MOST EASTERLY BOUNDARY OF ROAD PLAN 705EO, THEN WEST ACROSS THE FULL WIDTH OF ROAD PLANS 705EO AND 4011EO TO ITS INTERSECTION WITH THE MOST WESTERLY BOUNDARY OF ROAD PLAN 4011EU.

ALL THAT PORTION OF THE NORTHWEST QUARTER OF SECTION TWENTY-THREE (23), TOWNSHIP THIRTY-NINE (39), RANGE TWENTY-SEVEN (27), WEST OF THE FOURTH MERIDIAN, LYING NORTH OF THE MOST NORTHERLY BOUNDARY OF RIGHT-OF-WAY OF SECONDARY HIGHWAY 597.

ALL THAT PORTION OF THE NORTHEAST QUARTER OF SECTION TWENTY-TWO (22), TOWNSHIP THIRTY-NINE (39), RANGE TWENTY SEVEN (27), WEST OF THE FOURTH MERIDIAN, LYING NORTH OF THE MOST NORTHERLY BOUNDARY OF RIGHT-OF-WAY OF SECONDARY HIGHWAY 597.

ALL THAT PORTION OF THE NORTHWEST QUARTER OF SECTION TWENTY-TWO (22), TOWNSHIP THIRTY-NINE (39), RANGE TWENTY-SEVEN (27) WEST OF THE FOURTH MERIDIAN LYING NORTH OF THE MOST NORTHERLY BOUNDARY OF RIGHT-OF-WAY OF SECONDARY HIGHWAY 597 AND EAST OF THE MOST EASTERLY RIGHT-OF-WAY OF HIGHWAY 2.

ALL THAT PORTION OF THE SOUTHWEST QUARTER OF SECTION TWENTY-SEVEN (27), TOWNSHIP THIRTY-NINE (39), RANGE TWENTY-SEVEN (27) WEST OF THE FOURTH MERIDIAN, LYING EAST OF THE MOST EASTERLY BOUNDARY OF THE RIGHT-OF-WAY OF HIGHWAY 2.

ALL INTERVENING ROAD ALLOWANCES, ROADWAY PLANS, UTILITY RIGHT-OF-WAY PLANS, PIPELINE RIGHT-OF-WAY PLANS AND RAILWAY RIGHT-OF-WAY PLANS

EXCEPT FOR THOSE ROADWAY PLANS SPECIFICALLY EXCEPTED OUT OF THAT PORTION OF THE NORTHWEST QUARTER OF SECTION TWENTY-SIX (26), TOWNSHIP THIRTY-NINE (39), RANGE TWENTY-SEVEN (27), WEST OF THE FOURTH MERIDIAN.
