FORMATION OF THE TOWN OF CALMAR

Edmonton, Monday, January 25, 1954.

His Honour the Lieutenant Governor, by and with the advice of the Executive Council, has been pleased to order, that the prosopal to form the Village of Calmar be and is hereby acceded to so that on and from the 19th day of January 1954, the Village of Calmar shall be known and designated as the Town of Calmar and shall be comprised of the following area

Firstly Those portions of the south-east quarter of section 36, township 49, range 27, west of the fourth meridian, as shown on plans of subdivision registered in the Land Titles Office at Edmonton, numbered 6481ET, 4063ET, 4250EO and that portion covered by Certificate of Title number 89-N-132 and that portion of Center Avenue as shown on PWD Plan 946 which lies to the south and adjoins Plans 4250EO, 4063ET and Certificate of Title 89-N-132

Secondly All the light-of-way and station grounds of the Canadian Pacific Railway contained in the east half of section 25, township 49, range 27, west of the fourth meridian as shown on a plan of subdivision registered in the Land Titles Office as number 3274E O, those portions of the north-east quarter of section 25, township 49, lange 27, west of the fourth meridian, described as follows the most easterly 666 feet of the said quarter section lying north of and ad-, joining the right-of-way and station grounds of the Canadian Pacific Railway, that portion of the said quarter section lying east of a line commencing at a point on the north boundary of the said quarter section distant 396 feet west of the west boundary of Plan 3075ET and thence southerly and parellel to the eastern boundary of the said quarter section and north of the south boundary of Block P in Plan 334H W and its production westerly, that portion of the said quarter section shown on a plan of subdivision number 1556 HW; and that portion of Railway Avenue lying south and adjoining Plan 1556 HW, that portion of the said quarter section lying south of the production westerly of the north boundary of the lane in block 15, plan 1556HW and east of a line drawn parallel to and 105 2 feet distant west from the west boundary of plan 1556H W and north of the right-of-way and station grounds of the Canadian Pacific Railway

Thirdly Those portions of the south-west quarter of section 31, township 49, range 26, west of the fourth meridian as is shown on plans of subdivision registered in the Land Titles Office at Edmonton and numbered 4250E O, 334H W, 6312E T, 445H W, 3514E T, 3956H W, 2138H W and those portions covered by Certificates of Title Nos 12-S-91, 135-N-97, 116-F-79, 50-G-18 and 209-D-94; and that portion of the said quarter section lying south of the production easterly of the north boundary of Plan 6312E T and westerly of the production northerly of the eastern boundary of Plan 3956H W together with that portion of Center Avenue as shown on P.W D Plan No 946 lying south and adjacent to Plan 4250 E O, 445 H W, and 2138H W

Fourthly Those portions of the nc-th-west quarter of section 30, township 49, range 26, west of the fourth meridian as shown on plans of subdivision registered in the Land Titles Office at Edmonton and numbered 4250EO, 4063ET, 627HW, and 3418HW.

Further, that in accordance with the provisions of The Town and Village Act, 1952, the present council of the village shall, until the 2nd Monday in March, 1954, be deemed to be the council of the Town of Calmar and that the said council shall prepare for the election of a mayor and six councillors to take office on the 2nd Monday of March, 1954, in accordance with the said The Town and Village Act, 1952, in that behalf, and that the terms of office of the councillors so elected shall be governed by the provisions of section 98 of The Town and Village Act, 1952
