In the matter of "The Town and Village Act":

And in the matter of an application by the Village of Calmar for the annexation thereto of certain properties

Upon the application of the Village of Calmar in the Province of Alberta, upon reading the consent of the Municipal District of Leduc No 75; and upon reading the other material filed

It is ordered that the following described properties be detached from the Municipal District of Leduc No 75, and that the same be and they are hereby annexed to the Village of Calmar

Firstly. All that portion of the north-east quarter of section 25, township 49, range 27, west of the fourth meridian, subdivided under plan of subdivision of record in the Land Titles Office for the North Alberta Land Registration District as 1556 H W which has not been previously included in the Village limits

•*Secondly* All that portion of the north-west quarter of section 30, township 49, range 26, west of the fourth meridian, described as follows

Commencing at the point of intersection of the south boundary of the land subdivided under Plan 4063 E T, of record in the said Land Titles Office, with the east boundary of First Street East as shown on Subdivision Plan 627 H W, thence easterly along the said south boundary of the said Plan 4063 E T 200 feet, thence southerly and parallel to the said east boundary of the said First Street East 50 feet, thence westerly and parallel to the said south boundary of the said Subdivision Plan No 4063 E T to the said east boundary of the said First Street East, thence northerly along the said east boundary of First Street East to the point of commencement

Thirdly All that portion of the south-west quarter of section 31, township 49, range 26, west of the fourth meridian, described as follows

Commencing at the point of intersection of the east boundary of Second Street East as shown on Subdivision Plan 445 H W with the north boundary of First Avenue North as shown on said Plan, thence northerly along the production northerly of the east boundary of the said Second Street East to the intersection with the production easterly of the north boundary of lot 4, block 13, as shown on Subdivision Plan 6312 E T, thence westerly along the said production easterly of the said north boundary of said lot 4, block 13 to the east boundary of said block 13, thence southerly along the east boundary of said block 13 and its production southerly to the intersection with the north boundary of said First Avenue North as shown on Subdivision Plan 445 H W, thence easterly along the said north boundary to the point of commencement

Fourthly All that portion of the south-west quarter of section 31, township 49, range 26, west of the fourth meridian, as shown on Subdivision Plan 2138 H W., and

All that portion of the road as shown on Road Plan 3626 J which lies between the production southerly of the east boundary of lot 5 in block 14 as shown on Subdivision Plan 2138 H W, and the production northerly of the eastern boundary of lot C as shown on Subdivision Plan 627 H W, and

All those portions of the roads in the north-west quarter of section 30, township 49, range 26, west of the fourth meridian, as shown on Road Plans 3626 J and 257 J Y which lie between the production southerly of the east boundary of lot 5 in block 14 as shown on Subdivision Plan 2138 H W, and the production northerly of the east boundary of lot C as shown on Subdivision Plan 627 H W

This Order shall take effect as and from the 1st day of January, 1952
