In the matter of The Town and
Village Act, being chapter 338 of
The Revised Statutes of Alberta,
1955;

And in the matter of an appli-
cation by the Town of Calmar,
in the Province of Alberta, for the
annexation of certain lands.

Upon the application of the Town of Calmar; upon reading the consent of the Municipal District of Leduc No. 75; upon reading the consent of the Edmonton District Planning Commission; upon reading the consent of the owners of the properties concerned; upon reading the other material filed:

* It is ordered that the lands hereinafter described be detached from the Municipal District of Leduc No. 75 and that the same be and are hereby annexed to the Town of Calmar:

Firstly: (C. of T. 242 & 243-M-131)

All that portion of the north-east quarter of section 25, township 49, range 27, west of the fourth meridian, in the Province of Alberta, described as follows:

Commencing at a point on the south limit of the road as shown on Road Plan 317 J Y 297 feet westerly from the west limit of Second Street West as shown on subdivision plan 2092 H W, thence westerly along the said south limit 495 feet, thence southerly and parallel to the said west limit 231 feet, thence easterly and parallel to the said south limit 495 feet; thence northerly to the point of commencement

The land hereby described containing 2 62 acres more or less

Reserving thereout all mines and minerals.

Secondly (C of T 212-T-107).

All that portion of the south-east quarter of section 36, township 49, range 27, west of the fourth meridian, in the said Province, described as follows

Commencing at the point of intersection of the east boundary of the said quarter section and the north limit of First Avenue A North as shown on subdivision plan 6481 E T, Thence westerly along the said north limit 150 feet, thence northerly and parallel to the said east boundary 50 feet, thence easterly and parallel to the said north limit to the said east boundary, thence southerly along the said east boundary to the point of commencement.

Containing 0 17 of an acre, more or less

Reserving unto Her Majesty all mines and minerals

Thirdly (C of T 11-W-146)

All that portion of the south-west quarter of section 31, township 49, range 26, west of the fourth meridian, in the said Province, bounded as follows

On the west by the east limit of Second Street East as shown on subdivision plan 445 H.W, on the east by a straight line drawn northerly and parallel to the said east limit through the north-east corner of the land subdivided under Plan 2138 H W, On the north by the production easterly by north limit of First Avenue North as shown on the said subdivision plan 445 H W, On the south by the north limit of the lane in block 14 as shown on the said subdivision plans 445 H W and 2138 H W.

Containing 3 51 acres, more or less

Reserving thereout all mines and minerals

This order shall become effective on and from the 30th day of December, 1957.
