MINISTERIAL ORDER

ERECTION OF VILLAGE OF CALMAR

Whereas the undersigned, being satisfied that all requirements with regard to the erection of a Village under the provisions of The Town and Village Act, being Chapter 150 of the Revised Statutes of Alberta, 1942, have been substantially complied with, it is hereby ordered that the area described hereunder, namely

Those portions of the south-east quarter of section 36, township 49, range 27, west of the fourth meridian, as same is shown on plans of subdivision registered in the Land Titles Office at Edmonton numbered 6481ET, 4063ET, and 4250EO, together with that portion of Centre Avenue as same is shown on PWD Plan 946 which lies to the south and adjoins plans 4063ET and 4250EO

Those portions of the north-east quarter of section 25, township 49, range 27, west of the fourth meridian, more particularly described as follows the most easterly six hundred and sixty-six (666) feet of the said quarter section lying north and adjoining the right-of-way and station grounds of the Canadian Pacific Railway, as same is shown on plan 3274EO, that portion of the said quarter section lying east of a line, commencing at a point on the north boundary of the said quarter section distant three hundred and ninety-six (396) feet west of the west boundary of plan 3075ET and thence southerly and parallel to the eastern boundary of the said quarter section, and north of the south boundary of Block P in Plan 334HW and its production westerly, that portion of the said quarter section commencing at a point where the production westerly of the north boundary

of the lane in Block 1, Plan 4656E O intersects the westerly limit of First Street West as same is shown on the said plan 4656E O, thence westerly and parallel to the right-of-way and station grounds of the Canadian Pacific Railway distant seven hundred and sixty (760) feet to a point, thence southerly and parallel to the easterly boundary of the said quarter section to the northern boundary of the said right-of-way and station grounds, thence easterly along the northern boundary of the said right-of-way and station grounds to a point where the production southerly of the westerly boundary of First Street West, as same is shown on plan 4656E O, intersects the northern boundary of the said right-of-way and station grounds, thence northerly along the said production and the said west limit of First Street West to the point of commencement

All the right-of-way and station grounds of the Canadian Pacific Railway contained in the east half of section 25, township 49, range 27, west of the fourth meridian as same is shown on a plan of subdivision registered in the Land Titles Office as number 3274E O

Those portions of the south-west quarter of section 31, township 49, range 26, west of the fourth meridian, as same is shown on plans of subdivision registered in the Land Titles Office at Edmonton and

numbered 4250EO, 334HW, 6312ET 445HW and 3514ET and those portions covered by Certificates of Title Nos 12-S 91, 135-N-97, 116-F-79, 50-G-18 and 209-D-94

Those portions of the north-west quarter of section 30, township 49, range 26, west of the fourth meridian, as same is shown on plans of subdivision registered in the Land Titles Offfice at Edmonton and numbered 4250EO, 4063ET, and 627HW, together with that portion lying north of the north limit of Block A, Plan 627HW and its production easterly and west of the production southerly of the easterly limit of First Street East as same is shown on plan 627HW, together with that portion of Centre Avenue as same is shown on PWD Plan No 946 lying north and adjacent to that portion of plan 4250EO in the said quarter section and lying north and adjacent to block 15, plan 627HW,

be and it is hereby withdrawn from the Municipal District of Leduc No 75 and erected into a Village to be known as the Village of Calmar

It is further ordered that a Nomination Meeting for the first election of a Council be held between the hours of 7 o'clock and 8 o'clock in the evening on Monday, being the 31st day of January, 1949, for the purpose of receiving names of candidates for the office of Councillors

It is further ordered that, if an election is necessary, the polling day shall be Monday, being the 7th day of February, 1949, and that the election shall be conducted in accordance with the provisions of The Town and Village Act in that behalf

It is further ordered that in the event of a poll being required the first meeting of the new Council shall be held on Filday, being the 11th day of February, 1949, but in the event that no poll is required the first meeting of the new Council shall be held on Monday, being the 7th day of February, 1949

This Order shall be effective as on and from the 1st day of January, 1949
