The Executive Council has had under consideration the report of the Honourable the Acting Minister of Municipal Affairs, dated January 19th, 1954, stating that:

WHEREAS the Council of the Village of Calmar has expressed to the Minister of Municipal Affairs the desire that the said Village be formed into a Town; and

WHEREAS the said Village contains over seven hundred inhabitants; and

WHEREAS the aforesaid desire has been approved by two-thirds of the proprietary electors of the Village voting thereon at a meeting specially called for the purpose; and

WHEREAS the Secretary-Treasurer has furnished satisfactory proof of compliance with the provisions of The Town and Village Act/¹⁹⁵²with respect to the required formalities applicable to the formation of a Town;

THEREFORE, upon the recommendation of the Honourable the Acting Minister of Municipal Affairs, the Executive Council advises that the proposal to form the Village of Calmar be and is hereby acceded to so that on and from the Nineteenth day of January, A.D. 1954, the Village of Calmar shall be known and designated as the TOWN OF CALMAR and shall be comprised of the following area:

FIRSTLY: Those portions of the South East quarter of Section 36, Township 49, Range 27, West of the 4th Meridian, as shown on plans of subdivision registered in the Land Titles Office at Edmonton, numbered 6481 E.T., 4063 E.T., 4250 E.O. and that portion covered by Certificate of Title number 89-N-132 and that portion of Center Avenue as shown on P.W.D. Plan 946 which lies to the South and adjoins Plans 4250 E.O., 4063 E.T. and Certificate of Title 89-N-132.

SECONDLY: All the right of way and station grounds of the Canadian Pacific Railway contained in the East half of Section 25, Township 49, Range 27, West of the 4th Meridian as shown on a plan of subdivision registered in the Land Titles Office as number 3274 E.O., Those portions of the North East quarter of Section 25, Township 49, Range 27, West of the 4th Meridian, described as follows: the most Easterly Six Hundred and Sixty-six (666) feet of the said quarter section lying North of and adjoining the right-of-way and station grounds of the Canadian Pacific Railway; that portion of the said quarter section lying East of a line commencing at a point on the North boundary of the said quarter section distant Three Hundred and Ninety-six (396) feet West of the West boundary of Plan 3075 E.T. and thence Southerly and parallel to the Eastern boundary of the said quarter section and North of the South Boundary of Block P in Plan 334 H.W. and its production Westerly; that portion of the said quarter section shown on a plan of subdivision number 1556 H.W.; and that portion of Railway Avenue lying South of and adjoining Plan 1556 H.W.; that portion of the said quarter section lying South of the production Westerly of the North boundary of the lane in Block 15, Plan 1556 H.W. and East of a line drawn parallel to and One Hundred and Five and Two-tenths (105.2) feet distant West from the West boundary of Plan 1556 H.W. and North of the right-of-way and station grounds of the Canadian Pacific Railway.

THIRDLY: Those portions of the South West quarter of Section 31, Township 49, Range 26, West of the 4th Meridian as is shown on plans of subdivision registered in the Land Titles Office at Edmonton and numbered 4250 E.O., 334 H.W., 6312 E.T., 445 H.W., 3514 E.T., 3956 H.W., 2138 H.W. and those portions covered by Certificates of Title Nos. 12-S-91, 135-N-97, 116-F-79, 50-G-18 and 209-D-94; and that portion of the said quarter section lying South of the production Easterly of the North boundary of Plan 6312 E.T. and Westerly of the production Northerly of the Eastern boundary of Plan 3956 H.W. together with that portion of Center Avenue as shown on P.W.D. Plan No. 946 lying South and adjacent to Plan 4250 E.O., 445 H.W. and 2138 H.W.

FOURTHLY: Those portions of the North West quarter of Section 30, Township 49, Range 26, West of the 4th Meridian as shown on Plans of subdivision registered in the Land Titles Office at Edmonton and numbered 4250 E.O., 4063 E.T., 627 H.W., and 3418 H.W.

The Executive Council further advises, upon the recommendation of the Honourable the Acting Minister of Municipal Affairs, that, in accordance with the provisions of The Town and Village Act,¹⁹⁵² the present Council of the Village shall, until the Second Monday in March A.D. 1954, be deemed to be the Council of the Town of Calmar and that the said Council shall prepare for the election of a Mayor and Six Councillors to take office on the Second Monday in March, A.D. 1954, in accordance with the said The Town and Village Act,¹⁹⁵² in that behalf, and that the terms of office of the

Councillors so elected shall be governed by the provisions of section 98 of The Town and Village Act, 1952.

NOW THEREFORE the undersigned has the honour to recommend that the proposal to form the Village of Calmar into a Town be acceded to so that on and from the nineteenth day of January, A. D. 1954 the Village of Calmar shall be known and designated as the Town of Calmar and shall be comprised of the following area:

Firstly: Those portions of the south east quarter of Section 36, Township 49, Range 27, West of the 4th Meridian, as shown on plans of subdivision registered in the Land Titles Office at Edmonton numbered 6481 E.T., 4063 E.T., 4250 E.O. and that portion covered by Certificate of Title number 89-N-132 and that portion of Center Avenue as shown on P.W.D. plan 946 which lies to the south and adjoins plans 4250 E.O., 4063 E.T. and Certificate of Title 89-N-132.

Secondly: All the right of way and station grounds of the Canadian Pacific Railway contained in the east half of Section 25, Township 49, Range 27, West of the fourth Meridian as shown on a plan of subdivision registered in the Land Titles Office as number 3274 E.O. Those portions of the north east quarter of Section 25, Township 49, Range 27, West of the fourth Meridian described as follows; the most easterly six hundred and sixty-six, (666) feet of the said quarter section lying north of and adjoining the right of way and station grounds of the Canadian Pacific Railway; that portion of the said quarter section lying east of a line commencing at a point on the north boundary of the said quarter section distant three hundred and ninety six (396) feet West of the West boundary of plan 3075 E.T. and thence southerly and parallel to the eastern boundary of the said quarter section and north of the south boundary of Block P in Plan 334 H.W. and its production westerly; that portion of the said quarter section shown on a plan of subdivision number 1556 H.W.; and that portion of Railway Avenue lying south of and adjoining Plan 1556 H.W.; that portion of the said quarter section lying south of the

production westerly of the north boundary of the lane in Block 15, Plan 1556 H. W. and east of a line drawn parallel to and one hundred and five and two-tenths (105.2) feet distant West from the west boundary of Plan 1556 H.W. and north of the right of way and station grounds of the Canadian Pacific Railway.

Thirdly: Those portions of the south west quarter of Section 31, Township 49, Range 26, West of the fourth Meridian as is shown on plans of subdivision registered in the Land Titles Office at Edmonton and numbered 4250 E.O., 334 H.W., 6312 E.T., 445 H.W., 3514 E.T., 3956 H.W., 2138 H.W. and those portions covered by Certificates of Title Nos. 12-S-91, 135-N-97, 116-F-79, 50-G-18 and 209-D-94; and that portion of the said quarter section lying south of the production easterly of the north boundary of plan 6312 E.T. and westerly of the production northerly of the eastern boundary of Plan 3956 H.W. together with that portion of Center Avenue as shown on P. W. D. Plan No. 946 lying south and adjacent to Plan 4250 E.O., 445 H.W. and 2138 H.W.

Fourthly: Those portions of the north west quarter of Section 30, Township 49, Range 26, West of the fourth Meridian as shown on Plans of subdivision registered in the Land Titles Office at Edmonton and numbered 4250 E.O., 4063 E.T., 627 H.W., and 3418 H.W.

IT IS FURTHER RECOMMENDED THAT, in accordance with the provisions of The Town and Village Act, the present Council of the Village, shall until the second Monday in March, A.D. 1954 be deemed to be the Council of the Town of Calmar and that the said Council prepare for the election of a Mayor and six councillors to take office on the second Monday in March A.D. 1954, in accordance with the provisions of the said Town and Village Act in that behalf, and that the terms of office of the Councillors so elected shall be governed by the provisions of Section 98 of The Town and Village Act, 1952.
