The Executive Council has had under consideration the report of the Honourable the Minister of Public Works, of even date setting forth that satisfactory proof has been received that the area mentioned hereunder is not contained within any incorporated City, town or rural municipality; that the said area contains not less than Twenty-five occupied Dwelling Houses, and in accordance with the provisions of the "Village Act" in Section 3, he has caused Notices to be posted in three conspicuous places within the said area, one of which was the Post Office, announcing the intention to establish the area as a Village at the expiration of thirty days from the date of posting such notices. The Minister further reports that such Notices were posted at least thirty days prior to the date hereof.

Upon consideration of the foregoing report and upon the recommendation of the Honourable the Minister of Public Works the Executive Council advises that under the provisions of Section 4, of the "Village Act", The North West Quarter of Section twenty-five (25), the North East Quarter of Section twenty-six (26), south half of legal subdivisions one (1) and two (2), in section thirty-five (35), South half of legal subdivisions three (3) and four (4) in section thirty six (36), Township Twenty-eight, range one (1) west of the fifth meridian, be established a Village; that the Village be given the name of Crossfield; that James Cameron of Crossfield be returning Officer for the purpose of acting at the election of the first Council for the Village, and that the said Election for a Council for the Village in question, be held on Tuesday, July 2nd.1907.

The undersigned has the honor to report that having received satisfactory proof that the area mentioned hereunder, is not contained within any incorporated City, Town, or Rural Municipality, and that the said area contains not less than Twenty-five occupied Dwelling Houses, he has, in accordance with the provisions of Section 3 of the Village Act, caused Notices to be posted in three conspicuous places within the said area, one of which was the Post Office, announcing the intention to establish the area as a Village at the expiration of thirty days from the date of posting such Notices.

He further reports that such Notices were posted at least thirty days prior to the date hereof.

The undersigned therefore begs to recommend that, under the provisions of Section 4 of the Village Act, the North-West of Section 25, North-East of Section 26, South Half of legal sub-divisions 1 and 2, in Section 35, South Half of legal sub-divisions 3 and 4, in Section 36, Township 28, Range 1, West of the 5th Meridian be established a Village; that the village be given the name of CROSSFIELD; that James Cameron of Crossfield, be Returning Officer for the purpose of acting at the election of the first Council for the Village, and that the said Election for a Council for the Village in question, be held on *Tuesday July 2nd* ~~Monday, June 24th~~, 1907.
