

## TOWN OF EDSON

ORDER No. 12396

In the matter of The Municipal Government Act:

And in the matter of the Local Authorities Board, on its own motion, after notice, annexing certain territory lying immediately adjacent thereto in the Improvement District No. 14 to the Town of Edson, Alberta.

It having come to the attention of the board that it was desirable for general administrative purposes and to clarify jurisdictions over roads to annex to the Town of Edson, in the Province of Alberta, the following described territory and separate same from the Improvement District No. 14:

1. All that portion of the north-west quarter of section 22, township 54, range 17, west of the fifth meridian contained within road plan 5876 L.Z. and lying south of the production westerly across the said road plan of the south limit of road plan 5581 P.X.
2. All that portion of the north-east quarter of section 21, township 53, range 17, west of the fifth meridian contained within road plan 5876 L.Z. and lying south of the production westerly throughout of the south limit of road plan 5581 P.X.
3. That north south government road allowance intervening and adjoining the above-described lands.

And the board being satisfied that notice of the proposed annexation, pursuant to section 20 of The Municipal Government Act, was given respecting the proposal on its own motion to annex the said area to the Town of Edson for the aforesaid reasons; and having received no objections thereto from the Improvement District No. 14, the Town of Edson, Alberta Transportation and the Planning Services Division of Alberta Municipal Affairs.

Therefore, subject to the Lieutenant Governor in Council approving this order, or prescribing conditions that the order is subject to and approving the order subject to those conditions, or varying the order and approving the order as varied, it is ordered as follows:

I. That there be annexed to the Town of Edson, in the Province of Alberta, and thereupon be separated from the Improvement District No. 14, the following described territory which immediately adjoins the present limits of the Town of Edson:

1. All that portion of the north-west quarter of section 22, township 53, range 17, west of the fifth meridian contained within road plan 5876 L.Z. and lying south of the production westerly across the said road plan of the south limit of road plan 5581 P.X.
2. All that portion of the north-east quarter of section 21, township 53, range 17, west of the fifth meridian contained within road plan 5876 L.Z. and lying south of the production westerly throughout of the south limit of road plan 5581 P.X.
3. That north south government road allowance intervening and adjoining the above described lands.

A sketch showing the general location of the annexed lands is attached as Schedule "A".

II. That the effective date of this Order is the 1st day of January, 1980.
