WHEREAS the Development Officer of Improvement Districts numbered 79, 95 and 96, pursuant to section 4 of THE NEW TOWNS ACT, had made application to the Provincial Planning Advisory Board for the establishment of the hamlet of Hinton as a New Town; and

WHEREAS the Provincial Planning Advisory Board, having considered the application, have made certain recommendations with regard thereto; and

WHEREAS it is desirable and in the public interest to establish the hamlet of Hinton as a new Town;

THEREFORE, upon the recommendation of the Honourable the Acting Minister of Municipal Affairs, the Executive Council advises that, pursuant to the provisions of sections 3, 5 and 13 of The New Towns Act, being chapter 39 of the statutes of Alberta, 1956:

- (1) All that portion of the North West quarter of Section 10, the South half of Section 15 and the South West quarter of section 14 in Township 51, Range 25, West of the 5th Meridian, lying South of the North boundary of the railway right-of-way of the Canadian National Railway registered under Plan No. 7415 A.H. and the North East quarter of Section 10 and the North West quarter of Section 11 in Township 51, Range 25, West of the 5th Meridian, be and is hereby declared to be a new Town to be known as the New Town of Hinton.
- (2) The establishment of the New Town of H<sub>i</sub>nton shall be effective as, on and from the 1st day of November, 1956.
- (3) The Board of Administrators of the New Town of Hinton shall consist of:
