And in the matter of an appli-
cation by the Town of Mayer-
thorpe for the annexation to the
Town of certain adjacent terri-
tory.

Upon the application of the Town of Mayerthorpe, in the Province of Alberta, for an Order to include within the Town certain territory adjacent thereto, and upon hearing the petition of the Town and the evidence adduced at the hearing held in the Town of Mayerthorpe on Tuesday, the 13th day of February, 1962:

It is ordered that the lands hereinafter described, namely:

Firstly: All that portion of the west half of section 28, township 57, range 8, west of the fifth meridian, in the said Province, described as follows:

Commencing at the intersection of the north-east boundary of block A as shown on Subdivision Plan 373 C.L. with the east limit of 1st Street W. as shown on Subdivision Plan 2256 E.T.; thence northerly along the said east limit to intersection with the production easterly of the south limit of 2nd Avenue N. as shown on the said Plan 2256 E.T.; thence westerly along the said production and the said southerly limit to the west boundary of the north-west quarter of said section 28; thence northerly along the said west boundary to a point 840 feet northerly from the north-west corner of the said Block A; thence easterly and parallel to the north boundary of the said north-west quarter 770 feet; thence southerly and parallel to the said west boundary 195.6 feet; thence easterly and parallel to the said north boundary 136 feet more or less, to the north-west corner of Lot A as shown on Subdivision Plan 975 M.C.; thence easterly and southerly along the northerly and easterly boundaries of the lands subdivided under Plans 975 M.C., 637 H.W. and 2706 H.W. to the

north-east corner of the unnamed street as shown on the said Plan 2706 H.W.; thence along the production northerly of the east limit of the said unnamed street 15.2 feet; thence easterly and parallel to the south boundary of the said north-west quarter to a point on the east boundary of the said quarter section; thence southerly along the said east boundary and along the east boundary of the south-west quarter of the said section 28 to intersection with the north-east boundary of Block C as shown on the said Plan 373 C.L.; thence north-westerly along the said north-east boundaries of the said Blocks C and A as shown on the said Plan 373 C.L. to the point of commencement. Reserving thereout all mines and minerals.

Secondly: All that portion of the Original Road Allowance adjoining the west boundary of the said north-west quarter of the said section 28 which lies north of the production westerly of the south limit of the said 2nd Avenue N. as shown on the said Plan 2256 E.T. and south of a line drawn westerly and parallel to the north boundary of the said north-west quarter through a point on the west boundary thereof 840 feet northerly from the north-west corner of the said Block A as shown on the said Plan 373 C.L.

Reserving unto Her Majesty all mines and minerals.

be and the same are hereby annexed to and included in the Town of Mayerthorpe.

This Order shall take effect as and from the 30th day of December, 1961.
