tain territory adjacent to the
town.

Upon application of the Town of Mayerthorpe, in the Province of Alberta, for an order to include within the said town certain territory adjacent thereto; upon reading the consents of the County of Lac Ste. Anne No. 28, the Department of Highways, and the Edmonton Regional Planning Commission; and upon reading the other material filed:

It is ordered that the lands hereinafter described be detached from the County of Lac Ste. Anne No. 28 and that the same be and are hereby annexed to the Town of Mayerthorpe:

All that portion of the north-west quarter of section 28, township 57, range 8, west of the fifth meridian, shown as Parcel C, containing one and sixty-seven hundredths (1.67) acres more or less on Filed Plan 4264 N.Y.

(All as shown on the attached Schedule "A".)

That any taxes owing to the County of Lac Ste. Anne No. 28 as at the 31st day of December, 1966, in respect of the aforementioned property shall transfer to and become payable to the Town of Mayerthorpe, together with the amount of any lawful penalties and costs levied thereon in respect of such taxes; however, upon the town collecting any or all of the said taxes and lawful penalties and costs levied thereon, in respect of the said property, such collections shall forthwith be paid by the said town to the said county.

And it is further ordered that for taxation purposes commencing in the year 1967, the assessor for the Town of Mayerthorpe shall reassess the lands and assessable improvements thereon which were by this order annexed to it, so that the assessment thereof shall be fair and equitable with other related lands and assessable improvements in the Town of Mayerthorpe.

It is further ordered that the chief provincial assessor, appointed pursuant to the provisions of The Municipalities Assessment and Equalization Act, shall for taxation or grant purposes commencing in the year 1967, re-assess or revalue, as the case may be, all properties that are assessable or subject to valuation under the terms of The Electric Power and Pipe Line Assessment Act and The Municipal and Provincial Properties Valuation Act, within the areas by this order annexed to the Town of Mayerthorpe, so that the assessment or valuation shall be fair and equitable with properties of a similar nature.

This order shall take effect, as, on and from the 1st day of January, 1967.
