VILLAGE OF MAYERTHORPE INCORPORATED AS A TOWN

Edmonton, Monday, March 20, 1961. The Executive Council has had under consideration the report of the Honourable the Minister of Municipal Affairs, dated March 15th, 1961, stating that:

Whereas the Council of the Village of Mayerthorpe is desirous of having the village incorporated as a town; and

Whereas a meeting of the electors was held on Monday, February 13th, 1961, at which meeting the electors in attendance voted in favour of the proposal to have the village incorporated as a town; and

Whereas the Village of Mayerthorpe contains over seven hundred inhabitants; and

Whereas the Secretary-Treasurer of the village has furnished satisfactory proof of compliance with the provisions of The Town and Village Act, being chapter 338 of the Revised Statutes of Alberta, 1955, with respect to the required formalities applicable to the formation of a town:

Therefore, upon the recommendation of the Honourable the Minister of Municipal Affairs, the Executive Council advises that the request to form the Village of Mayerthorpe into a town be acceded to so that on and from the date of this Order, the Village of Mayerthorpe shall be known and designated as the Town of Mayerthorpe and shall be comprised of the lands described in the Schedule hereto.

The Executive Council further advises, upon the recommendation of the Honourable the Minister of Municipal Affairs, that in accordance with the provisions of section 29 of The Town and Village Act, the present Council of the Village of Mayerthorpe shall be deemed to be the Council of the Town of Mayerthorpe until the fifth Monday following the fourth Wednesday in September, 1961, and that the said Council prepare for the election of a mayor and six councillors to take office on the fifth Monday following the fourth Wednesday in September, 1961, in accordance with the provisions of The Town and Village Act, in that behalf, and that the terms of office of the mayor and councillors so elected shall be governed by sections 43 and 102 of The Town and Village Act.

SCHEDULE

All that portion of the west half of section 28, township 57, range 8, west of the fifth meridian, in the Province of Alberta, described as follows:

Commencing at a point where the northerly boundary of Block A, as shown on Registered Plan No. 373 C.L. intersects the westerly limit of the said section; thence northerly along the westerly boundary of the said section a distance of 433.9 feet, more or less, to the point of intersection with the northerly boundary of Second Avenue North as shown on Registered Plan No. 2256 E.T.; thence easterly along the said northerly boundary of the said Second Avenue North a distance of 160 feet, more or less, to a point; then southerly and parallel to the westerly boundary of the said section to the point of intersection with the northerly boundary of the said Block A; thence south-easterly along the north-easterly boundary of Blocks A and C, as shown on Registered Plan No. 373 C.L. to the easterly boundary of the west half of the said section; thence southerly along the said easterly boundary of the said half section a distance of 371.7 feet more or less to the point of intersection with the south-westerly boundary of Block B as shown on Registered Plan No. 373 C.L.; thence north-westerly along the south-westerly boundary of the said Block B to the point of intersection with the south-easterly boundary of the road as shown on Road Plan No. 1023 C.L.; thence south-westerly along the said south-easterly boundary of the said road to the south-westerly corner of the said road thence north-westerly along the south-westerly boundary of the said road to the point of intersection with the easterly boundary of Fourth Street East as shown on Registered Plan No. 4066 H.W.; thence southerly along the said easterly boundary of the said Fourth Street East a distance of 188.6 feet more or less to the point of intersection with the southerly boundary of Registered Plan No. 4066 H.W.; thence westerly along the southerly boundary of the said plan a distance of 699 feet, more or less, to the point of intersection with the easterly boundary of Second Street East as shown on Registered Plan No. 4066 H.W.; thence southerly along the said easterly boundary of Second Street East and its production southerly a distance of 306 feet, more or less to the point of intersection with the southerly boundary of Fourth Avenue and its production easterly as shown on Registered Plan No. 4066 H.W.; thence westerly along the said southerly boundary of the said Fourth Avenue and its production

easterly to the point of intersection with the easterly boundary of First Street West as shown on Registered Plan No. 953 K.S.; thence southerly along the said easterly boundary of First Street West as shown on Registered Plans No. 953 K.S. and 5553 K.S. and its production southerly to the point of intersection with the production easterly of the south boundary of Fifth Avenue as shown on Registered Plan No. 553 K.S.; thence westerly along the said southerly boundary of Fifth Avenue and its production easterly to the point of intersection with the westerly boundary of the west half of section 28; thence northerly along the westerly boundary of the said section to the point of commencement.

All that portion of the east half of section 29, township 57, range 8, west of the fifth meridian in the Province of Alberta, described as follows:

Commencing at the point of intersection of the easterly boundary of the east half of the said section with the southerly boundary of Fourth Avenue as shown on Registered Plan No. 2301 E.T.; thence westerly along the said south boundary of Fourth Avenue and its production westerly a distance of 1140 feet, more or less, to a point; thence northerly and parallel with the easterly boundary of the said section a distance of 1040 feet, more or less, to the point of intersection with the production westerly of the northerly boundary of Second Avenue as shown on Registered Plan No. 8371 E.T.; thence westerly along the production westerly of the north boundary of the said Second Avenue a distance of 500.81 feet, more or less to a point; thence northerly and parallel with the easterly boundary of the said section a distance of 759 feet more or less to the point of intersection with the northerly boundary of Road Plan No. 5134 E.O.: thence easterly and southerly along the northerly boundary of Road Plan No. 5134 E.O. to the point of intersection with the easterly boundary of the said section; thence southerly along the easterly boundary of the said section to the point of commencement.

All of the Government Road Allowance between sections 28 and 29, township 57, range 8, west of the fifth meridian lying north of the production easterly of the southerly boundary of Fourth Avenue as shown on Registered Plan No. 2301 E.T. and south of the production westerly of Second Avenue North as shown on Registered Plan No. 2256 E.T.
