Application having been made to the Board of Public Utility Commissioners for an Order annexing the properties hereinafter described to the Town of Ponoka, and the Board having heard the said application at the Town of Ponoka on Monday, the seventh day of June, 1951

It is ordered that the properties hereinafter described be detached from the Municipal District of Ponoka, No 66, and that the same be and they are hereby annexed to the Town of Ponoka

Commencing at the point of intersection of the east boundary of section 8, township 43, range 25, west of the fourth meridian, with the production westerly of the north boundary of block 12, Plan 256 H W, thence southerly along the said easterly boundary of the said section 8 to the north boundary of the north-east quarter of section 5, township 43, range 25, west of the fourth meridian, thence westerly along the north boundary of the said section 5 to the westerly boundary of plan of subdivision 455 H W, thence southerly along the said west boundary of said Plan 455 H W, and along its production southerly to the north-west limit of Road Plan No 14730, thence south-westerly along the said road Plan No 14730 to its

intersection with the westerly boundary of the south-east quarter of section 5, thence southerly along the said west boundary and its production southerly to the north boundary of section 31, township 42, range 25, west of the fourth meridian, thence easterly to the westerly boundary of the north-east quarter of section 31; thence southerly along the said west boundary to the southerly boundary of the said north-east quarter of said section 31, thence easterly along the said southerly boundary and its production easterly and along the southerly boundary of the north-west quarter of section 32, to the east boundary of the said north-west quarter, thence northerly along the said east boundary of the said quarter section to the north boundary of the said section 32, township 42, range 25, west of the fourth meridian thence easterly along the north boundary of the said section to its intersection with the production southerly of the east boundary of section 4, township 43, range 25, west of the fourth meridian; thence northerly along the said production and the said easterly boundary of the said section 4 and the easterly boundary of section 9, township 43, range 25, west of the fourth meridian to the intersection with the north-west limit of Road Plan 5977 MD, thence south-westerly along the north-west limit of the said road to the north boundary of section 4, township 43, range 25, west of the fourth meridian, thence westerly along the said north boundary to the intersection with the east boundary of the railway right-of-way as shown on registered Plan C and E No 1, thence north-easterly along the said easterly limit of the said right-of-way to the intersection with the production easterly of the north boundary of lot 4, block 1, registered Plan No 2524 ET, thence westerly along the said production easterly of the said lot 4 to the westerly limit of the railway right-of-way as shown on Plan \tilde{C} and \tilde{E} No. 1; thence northeasterly along the said westerly limit of the said railway right-of-way to the production easterly of the south boundary of Block 15 A, as shown on Registered Plan 1693 H W, thence westerly along the said production easterly of the south boundary of the said Block 15 A to the east boundary of registered plan 1693 HW, thence northerly along the said easterly boundary to the north boundary of the said plan, thence westerly along the said north boundary to the west boundary thereof, thence southerly along the said west boundary to the north boundary of Plan 256 HW, thence westerly along the said north boundary to the west boundary of the said plan, thence southerly along the west boundary to the north boundary of block 12, Plan No 256 HW, thence westerly along the production westerly of the north boundary of said block 12 to the Point of commencement Excepting thereout and therefrom the following.

Commencing at a point of intersection of the south boundary of section 9, township 43, range 25, west of the fourth meridian, and the east limit of the railway right-of-way as shown on Plan C and E. No 1; thence westerly along the south boundary of the said section 9 and its production westerly, and along the south boundary of section 8, township 43, range 25, west of the fourth meridian, to the westerly limit of plan of subdivision No 455 H W, thence southerly along the west limit of the said Plan 455 H W, to the southerly limit of 54th Avenue as shown on the said plan, thence easterly along the said southerly limit of 54th Avenue a distance of 528 feet more or less westerly from the easterly boundary of section 5, township 43, range 25, west of the fourth meridian, (this point being on the production northerly of the west boundary of Registered Plan No ,344 H W); thence southerly along the production northerly of the said plan 344 H W, and the westerly boundary of the said plan

and southerly along this production southerly to the south boundary of block 34 as shown on Registered Plan No 455 HW, thence easterly along the said south boundary of the said block 34, Plan 455 H W to the east boundary of section 5, thence southerly along the east boundary of the said section 5 and its production southerly to the north boundary of section 31, township 42, range 25, west of the fourth meridian, thence easterly along the north boundary of the said section 31 to the south-east limit of the railway right-of-way as shown on Plan C and E No 1, thence north-easterly along the south-easterly boundary of the said railway right-of-way as shown on Plan C and E No 1 to the south-west boundary of Registered Plan No 6873 BZ, thence south-easterly along the said south-west boundary of the said Plan 6873 BZ, to the south-east corner thereof, thence north-easterly along the south-east boundary of the said Plan 6873 BZ to the north-east corner thereof, thence northwesterly along the north-east boundary of the said Plan 6873 BZ to the south-east boundary of the station grounds as shown on Plan C and E No 1, thence north-easterly, north-westerly and northeasterly along the south-east, north-east and south-east boundaries of the station grounds and railway right-of-way as shown on Plan C and E No 1 to the point of commencement

This Order shall be deemed to have been effective as and from the 1st day of January, 1951
