Upon the application of the Town of Ponoka in the Province of Alberta, for an Order to include within the Town certain territory adjacent thereto, and upon hearing the petition of the Town and the representations of certain interested parties at a public hearing of the matter held in the Town of Ponoka on the 30th day of November, 1962; and on the basis of the evidence adduced therefrom, and upon consideration of other relevant representations and materials filed with the Board

It is ordered that the lands hereinafter described, namely:

Firstly All that portion of the north-east quarter of section 5, township 43, range 25, west of the fourth meridian bounded as follows. On the north by the north boundary of the said quarter section, on the west by the west boundary of the said quarter section, on the east by the west boundary of Subdivision Plans 455 H.W. and 5294 H.W. and their productions southerly throughout and on the south by the production westerly throughout of the said quarter section of the north boundary of the parcel of land as shown on filed Plan 3689 E O containing 27 acres, more or less

Secondly: All that portion of the south-east quarter of section 8, township 43, range 25, west of the fourth meridian, in the said Province, described as follows Commencing at the intersection of the south boundary of the said quarter section and the west limit of the area taken for Institutional purposes as shown on Road Plan 5616 K S, thence northerly along the said west limit of said area and its production northerly to a point 33 feet distant northerly thereon from the north-west corner of the said area; thence westerly and parallel to the said south boundary to a point on the west boundary of the said quarter section; thence southerly along the said west boundary to the south-west corner of the said quarter section, thence easterly along the said south boundary to the point of commencement

The land hereby described containing 19 38 acres, more or less

Thirdly All that portion of the south-east quarter of section 8, township 43, range 25, west of the fourth meridian taken for Institutional purposes as shown shaded in red on Road Plan 5616 K S. containing 6 70 acres, more or less

Fourthly Parcel A containing 0 79 of an acre, Plan 2428 M C (Ponoka S E 8-43-25-4)

Fifthly. All that portion of the south-west quarter of section 9, in the said township 43, range 25, west of the fourth meridian not presently within the limits of the Town of Ponoka

Sixthly All that portion of the original road allowance adjoining the west boundary of the said south-west quarter of section 9, which lies north of the present limit of the Town of Ponoka drawn across the said road allowance.

Seventhly All that portion of north-west quarter of section 9 in the said township 43, range 25, west of the fourth meridian required for road as shown on Road Plan 219 J Y

Eighthly All that portion of the south-east quarter of section 9 in township 43, range 25, west of the fourth meridian which lies north of the present limit of the Town of Ponoka and west of the easterly limit of the road as shown on Road Plan 1416 E U

Ninthly. All that portion of the north-east quarter of section 9 in the said township 43, range 25, west of the fourth meridian which lies south of the north boundary of Parcel "B" and the production thereof easterly as shown on filed Plan 5286 H W and west of the easterly limit of the road as shown on Road Plan 1416 E U.

be and the same are hereby annexed to the Town of Ponoka and are detached from the County of Ponoka No 3

This Order shall take effect on and from the 30th day of December, 1962
