The Executive Council has had under consideration the report of the Honourable the Acting Minister of Municipal Affairs, dated August 8th, 1939, stating that:

WHEREAS the Council of the Village of ROCKY MOUNTAIN HOUSE has advised the Honourable the Acting Minister of Municipal Affairs that the Village now contains over seven hundred (700) inhabitants, and that it is their desire that the status of the Village be changed to that of a Town; and

WHEREAS a public meeting of the electors of the Village has been held in conformity with the provisions of THE TOWN AND VILLAGE ACT in that behalf; and

WHEREAS the Secretary-Treasurer of the said Village of Rocky Mountain House has furnished substantial proof that the provisions of The Town and Village Act, being Chapter 49 of the Statutes of Alberta, 1934, together with all amendments thereto, with regard to the formation of a town, have been substantially complied with;

THEREFORE, upon the recommendation of the Honourable the Acting Minister of Municipal Afters, the Executive Council advises that the proposal to form the said Village of Rocky Mountain House into a Town, be given effect to, and that a Proclamation be published in the Alberta Gazette, and that on and after such publication the Village of Rocky Mountain House be known and designated as the TOWN OF ROCKY MOUNTAIN HOUSE, and consist of the following area:-

That portion of the North-east quarter of Section 22, Township 39, Range 7, West of the 5th Meridian, which is registered in the Land Titles Office for the North Alberta Land Registration District as Plan No. 101 A.J.

That portion of the South-east quarter of Section 27, Township 39, Range 7, West of the 5th Meridian, known as the Williams Subdivision and registered in the Land Titles Office for the North Alberta Land Registration District as Plan No. 5273 C.L., together with three acres, more or less, in the south-west corner of said quarter-section as per details filed in the Land Titles Office, Edmonton, under Certificate of Title No. 48-1-36. The unsubdivided portion of the north-east quarter of Section 22, Township 39, Range 7, West of the 5th Meridian.

All of Legal Subdivision 11, of Section 22, Township 39, Range 7, West of the 5th Meridian.

All that portion of Legal Subdivision 14, of Section 22, Township 39, Range 7, West of the 5th Meridian, which lies to the South of the North boundary of the public highway shown on a plan of record in the Department of Public Works as Plan No. 11934.

All that portion of Legal Subdivision 14, of Section 22, Township 39, Range 7, West of the 5th Meridian, described as follows:-

Commencing at a point on the eastern boundary of the said legal subdivision, distant 34 feet northerly from the northern limit of the public highway shown on a plan of record in the Department of Public Works as Plan No. 11934, thence westerly and parallel with the northern limit of said roadway 293 feet; thence northerly and parallel with the estern boundary of said legal subdivision 330 feet; thence easterly and parallel with the said northern limit of said roadway, to the eastern boundary of said legal subdivision; thence southerly along the said eastern boundary of said legal subdivision to the point of commencement.

That portion of the South-east quarter of Section 22, Township 39, Range 7, West of the 5th Meridian, lying to the east of the westerly boundary of the Canadian Pacific Railway right-of-way; and

That portion of the South-east quarter of Section 22, Township 39, Range 7, West of the 5th Meridian, lying north and east of the westerly boundary of the Canadian Nation Railway right-of-way.

All that portion of the South-east quarter of Section 23, in Township 39, Range 7, West of the 5th Meridian, which lies to the north of the northerly boundary of the Canadian National Railway, and to the west of the westerly boundary of the Caboose Track of the said Canadian National Railway, together with all that portion of the road allowance lying between Sections 22 and 23 in said Township 39, Range 7, West of the 5th Meridian, which has been closed and cancelled, and which lies to the north of the southerly boundary of the main line of the said Canadian National Railway.

All that portion of the road allowance between Sections 22 and 23 in Township 39, Range 7, West of the 5th Meridian, lying between the production easterly of the southerly boundary of the north-east quarter of said Section 22 and the northerly boundary of the closed and cancelled portion of the said road allowance.

The Executive Council further advises upon the recommendation of the Honourable the Acting Minister of Municipal Affairs, that the Council of the Village of Rocky Mountain House shall, until the third Monday in February next, following the publication of the Proclamation, be deemed to be the Council of the Town of Rocky Mountain House, and have all the powers and be charged with all the duties of a Town Council, and that the said Council prepare for the election of a Mayor and six councillors, in accordance with the provisions of The Town and Village Act, in that behalf, and that the term of office of the councillors elected at the said election shall be governed by the provisions of Section 46 of The Town and Village Act.

All that portion of the road allowance between Sections 22 and 23 in Township 39, Range 7, West of the 5th Meridian, lying between the production easterly of the southerly boundary of the north-east quarter of said Section 22 and the northerly boundary of the closed and cancelled portion of the said road allowance.

Council of the Village of ROCKY MOUNTAIN HOUSE shall, until the third Monday in February next, following the publication of the Proclamation, be deemed to be the Council of the Town of ROCKY MOUNTAIN HOUSE, and have all the powers and be charged with all the duties of a Town Council, and that the said Council prepare for the election of a Mayor and six councillors, in accordance with the provisions of The Town and Village Act, in that behalf, and that the term of office of the councillors elected at the said election shall be governed by the provisions of Section 46 of The Town and Village Act.
