Upon the application of the majority of owners of certain territory lying immediately adjacent to the Town of Taber, in the Province of Alberta for the purpose of residential development, the Board has considered the written representations.

The Councils of the Town of Taber, and the Municipal District of Taber No. 14, Alberta Transportation, and Oldman River Regional Planning Commission had no objection to the annexation proposal.

It appears to the Board that the application should be granted for the reasons stated by the applicant.

Therefore, subject to the Lieutenant Governor in Council approving this Order, or prescribing conditions that the Order is subject to and approving the Order subject to those conditions, or varying the Order and approving the Order as varied, IT IS ORDERED THEREFORE, AS FOLLOWS:

I. That there be annexed to the Town of Taber, in the Province of Alberta and thereupon be separated from the Municipal District of Taber No. 14 the following described territory:

Block 4, Plan 7710425.

(A sketch showing the general location of the annexed lands is attached as Schedule "A")

II. That any taxes owing to the Municipal District of Taber No. 14 as at December 31, 1978, in respect of the aforementioned properties shall transfer to and become payable to the Town of Taber together with any lawful penalties and costs levied thereon in respect of such taxes; however, upon the Town of Taber collecting any or all of such taxes, penalties or costs, such collections shall forthwith be paid by the Town to the Municipal District of Taber No. 14.

III. That the assessor for the Town of Taber shall for taxation purposes in the year 1979, re-assess the annexed lands and assessable improvements thereon, which are by this Order annexed to the Town so that the assessment thereof shall be fair and equitable with other lands and assessable improvements in the Town of Taber.

IV. That the Chief Provincial Assessor, appointed pursuant to the provisions of The Municipalities Assessment and Equalization Act shall for taxation or grant purposes commencing in the year 1979, re-assess or re-value as the case may be, all properties that are assessable or subject to valuation, under the terms of The Electric Power and Pipe Line Assessment Act and The Municipal and Provincial Properties Valuation Act, and which lie within the areas that are by this Order annexed to the Town of Taber, so that the assessment or valuation shall be fair and equitable with properties of a similar nature.

V. That the effective date of this order is the 1st day of January, 1979.

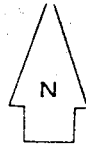
