The Executive Council has had under consideration the report of the Honourable, The Acting Attorney General, bearing even date, wherein he states that he has had under consideration the petition of the Overseer of the Village of Taber for the erection of the said Village into a town municipality, under the provisions of " The Municipal Amendment Ordinance 1901.

The Acting Attorney General further states that satisfactory proof of the preliminary acts and requirements requisite to the erection of the said village into a Town has been furnished.

Upon consideration of the foregoing report and on the recommendation of the Acting Attorney General, the Executive Council advises that Proclamation of His Honour, The Lieutenant Governor do issue proclaiming that on and after the 1st day of July, 1907, the said village of Taber be erected into a town municipality to be known as the Town of Taber, that the area of the said town of Taber consist of all of Section Five (5), Township ten (10) the north west quarter of section Thirty-Two (32); the north east quarter of section Thirty-one (31) and that portion of the north east quarter of section thirty-two(32), lying north of the C.P.R. Tracks.



All in Township 9. Range sixteen (16) west of the fourth meridian in the Province of Alberta. Excluding that part of the north east quarter of section 31, in township nine (9) Range sixteen (16) west of the fourth meridian lying south of the C.P.R. Track; and that David Burbanks of Taber, Alberta be named as the Returning Officer for the holding of the first election of Mayor and Councillor for the said Town.

The undersigned further reports that satisfactory proof of the preliminary acts and requirements requisite to the erection of the said Village into a Town has been furnished.


The undersigned therefore recommends that Your Honour's proclamation do issue proclaiming that on and after the 1st day of July, 1907, the said Village of Taber be erected into a town municipality to be known as the TOWN OF TABER, and that the area of the said Town of Taber consist of all of Section Five(5), Township Ten(10); the North-West quarter of Section Thirty-two(32); the North-East quarter of Section Thirty-one(31), and that portion of the North-East quarter of Section Thirty-two(32) lying north of the C.P.R. track, all in Township Nine(9), Range Sixteen(16) West of the Fourth(4th) Meridian, in the Province of Alberta, excluding that part of the North-East quarter of Section Thirty-one(31) in Township Nine,(9), in Range Sixteen(16) West of the Fourth Meridian lying south of the C.P.R. track.

The undersigned further recommends that



David Burbanks, of Taber, Alberta, be named as the returning officer  
for the holding of the first election of mayor and coun-  
cillors for the said town.

Re: Alteration of Boundaries of Town of Taber

I am returning herewith your recommendation for Order in Council to amend the Proclamation which established the Town of Taber on July 1st, 1907 - (Order in Council 391/07)

The recommendation does not appear to be in order in its present form and I should appreciate it if you would obtain a legal opinion as to whether the Proclamation may be altered.

Section 35 of The Town and Village Act, 1952, which sets forth powers of the Board of Public Utility Commissioners with regard to alteration of boundaries of towns which may apply in this instance.
