It having come to the attention of the Board that it was desirable for general administrative purposes and to clarify jurisdictions over roads to annex to the Town of Vegreville in the Province of Alberta the following described territory and separate same from the County of Minburn No. 27:

All that portion of the south half of section 23, township 52, range 15, west of the fourth meridian contained in Road Plans 5329 T. and 6516 N.Y.

All that portion of the north half of section 14, township 52, range 15, west of the fourth meridian contained in Road Plans 5329 T. and 6516 N.Y.

All that portion of the north-south government road allowance adjoining the west boundary of the north-west quarter of section 14, township 52, range 15, west of the fourth meridian which lies north of the production west across the said road allowance of the south limit of Road Plan 6516 N.Y.

All that portion of the north-east quarter of section 15, township 52, range 15, west of the fourth meridian contained in Road Plans 1673 N.Y. and 5329 T., and which lies north of the production west across the said Road Plan 1673 N.Y. of the south limit of Road Plan 6516 N.Y. and east of the production north across the said Road Plan 5329 T. of the west limit of said Road Plan 1673 N.Y.

The north-south government road allowance adjoining the west boundary of the west half of section 23, township 52, range 15, west of the fourth meridian.

All that portion of the south-east quarter of section 22, township 52, range 15, west of the fourth meridian contained in Road Plan 5329 T. which lies east of the Production north across the said road plan of the west limit of Road Plan 1673 N.Y.

And the Board being satisfied that notice of the proposed annexation, pursuant to section 20 of The Municipal Government Act, was given respecting the proposal on its own motion to annex the said area to the Town of Vegreville for the aforesaid reasons; and having received no objections thereto from the County of Minburn No. 27, Alberta Transportation, and the Town of Vegreville:

Subject to the approval of the Lieutenant Governor in Council, IT IS ORDERED, therefore as follows:

I. That there be annexed to the Town of Vegreville in the Province of Alberta, and thereupon be separated from the County of Minburn No. 27 the following described territory which immediately adjoins the present limits of the Town of Vegreville:

All that portion of the south half of section 23, township 52, range 15, west of the fourth meridian contained in Road Plans 5329 T. and 6516 N.Y.

All that portion of the north half of section 14, township 52, range 15, west of the fourth meridian contained in Road Plans 5329 T. and 6516 N.Y.

All that portion of the north-south government road allowance adjoining the west boundary of the north-west quarter of section 14, township 52, range 15, west of the fourth meridian which lies north of the production west across the said road allowance of the south limit of Road Plan 6516 N.Y.

All that portion of the north-east quarter of section 15, township 52, range 15, west of the fourth meridian contained in Road Plans 1673 N.Y. and 5329 T. and which lies north of the production west across the said Road Plan 1673 N.Y. of the south limit of Road Plan 6516 N.Y. and east of the production north across the said Road Plan 5329 T. of the west limit of said Road Plan 1673 N.Y.

The north-south government road allowance adjoining the west boundary of the west half of section 23, township 52, range 15, west of the fourth meridian.

All that portion of the south-east quarter of section 22, township 52, range 15, west of the fourth meridian contained in Road Plan 5329 T. which lies east of the production north across the said road plan of the west limit of Road Plan 1673 N.Y.

II. The effective date of this Order is the 1st day of January, 1979.
