Upon the application of the Town of Vegreville, and it appearing that by Order No. 1562 of The Board of Public Utility Commissioners, made on the 25th day of April, 1921, it was ordered that the pieces or parcels of land more particularly described in the said Order be separated from the Corporation of the Town of Vegreville:

And it further appearing that by inadvertence or misdescription the said Order failed to separate the road or street hereinafter described:

It is ordered that Order No. 1562 of The Board of Public Utility Commissioners, made on the 25th day of April, 1921, be and the same is hereby amended by adding thereto after sub-paragraph (e) sub-paragraph (f) as follows:

"(f) All that part of Main Street as shown on said Plan of Subdivision No. 4100 R which lies north of the production across said street of the northerly limit of Brockville Avenue as shown on said Plan 4100 R."

And it is further ordered that the land so separated be added to and form part of the lands included in the Municipal District of Eagle No. 81.

In the matter of The Public Utilities Act:

And in the matter of an application by Clarence L. Starr and Charles Gordon for the separation of certain portions of the south-west quarter of section 17 in Township 52, Range 14, west of the Fourth Meridian from the Town of Vegreville.

Upon the application of Clarence L. Starr and Charles Gordon, upon hearing the representatives of all parties interested, and upon reading the material filed:

It is ordered that Blocks "A" and "B," Plan 2643-A.Y., owned by the applicant Starr, and the 10-acre block of land in the south-west quarter of section 17 in Township 52, Range 14, west of the Fourth Meridian, and adjoining the western boundary of said quarter section and more particularly described in Certificate of Title No. 19 B.34 standing in the name of Charles Gordon, be separated from the Town of Vegreville, but that the said lands continue to be liable for the payment of any debenture indebtedness of the said Town incurred prior to this order in the same manner as if such separation had not been effected.
