MINISTERIAL ORDER

ERECTION OF THE VILLAGE OF WHITECOURT

Whereas the undersigned being satisfied that all requirements with respect to the incorporation of a Village under the provisions of The Town and Village Act being chapter 338 of The Revised Statutes of

Alberta 1955, and amendments thereto, have been substantially complied with, it is hereby ordered that the area described hereunder, namely:

The north half of section 26; all of section 35 excepting thereout those portions west of the right bank of the McLeod River and north of the right of way of the Canadian Northern Railway as shown on right of way location plan 344; those parts of section 34 covered by registered plans 3671 KS, 3823 KS, 2269 KS, 3356 KS, Road Plan 3300 JY and that part of the Canadian Northern Railway right of way as shown on right of way location plan 344 located in the southeast quarter of section 34, township 59, range 12 and that part of the southeast quarter of section 34, township 59, range 12 lying north of registered plan 3356 KS and west of road plan 3300 JY

All of the above described lands lying west of the fifth meridian.

Reserving thereout all mines and minerals.

Be and is hereby withdrawn from Improvement District No. 109 and erected into a Village to be known as the Village of Whitecourt.

It is further ordered, that a nomination meeting for the first election of a council be held between the hours of eleven o'clock in the forenoon and twelve o'clock noon on Monday, February 2nd, 1959 for the purpose of receiving names of candidates for the office of councillor.

It is further ordered that if an election is necessary, the polling day shall be Monday, February 16th, 1959 and that the election shall be conducted in accordance with the provisions of The Town and Village Act, chapter 338 of The Revised Statutes of Alberta, 1955, in that behalf.

It is further ordered that the first meeting of the new council shall be held on Monday, February 23rd, 1959.

It is further ordered that Leo Rene Maurice be and is hereby appointed Official Administrator of the Village from its erection on January 1st, 1959, to the first meeting of the new council and that he shall have full power and authority to make arrangements necessary for the election ordered above.

This order shall be effective as on and from the first day of January 1959, except that for the purpose of Certificates of Assessment as required by Sections 284 and 297 of The School Act, Chapter 297 of the Revised Statutes of Alberta 1955, and Section 110 of The Municipal Hospitals Act, chapter 216 of The Revised Statutes of Alberta, 1955, this order shall be deemed to have been in effect as of the 31st day of December 1958.
