Authorities Board, on its own mo-
tion, after notice, annexing certain
property to the Village of Clyde,
Alberta.

Pursuant to the provisions of section 20 of The Municipal Govern-
ment Act, the Board gave notice to the Municipal District of Westlock
No 92, the Village of Clyde, the Department of Highways and Trans-
port, Alberta, and the Provincial Planning Director, Alberta, of its
proposal to annex to the Village of Clyde, Alberta and thereupon sepa-
rate from the Municipal District of Westlock No 92, the following lands
described on Schedule "B" attached to this Order

And having received consents from all said parties to the proposal,
and being of opinion that the matter of the proposed annexation should
now be implemented,

It is ordered, therefore, on the Board's own motion, that there be
annexed to the Village of Clyde, Alberta, and thereupon be separated
from the Municipal District of Westlock No 92, all of the lands de-
scribed in Schedule "B" attached to this Order

(A sketch showing the general location of the annexed lands is
attached as Schedule "A" to this Order)

It is further ordered that the chief provincial assessor, appointed
pursuant to the provisions of The Municipalities Assessment and Equal-
ization Act, shall for taxation or grant purposes commencing in the year
1973, re-assess or re-value, as the case may be, all properties that are
assessable or subject to valuation under the terms of The Electric
Power and Pipe Line Assessment Act and The Municipal and Provincial
Properties Valuation Act, and which lie within the areas that are by
this Order annexed to the Village of Clyde, so that the assessment or
valuation shall be fair and equitable with properties of a similar nature

The effective date of this Order shall be the 1st day of January,
1972.

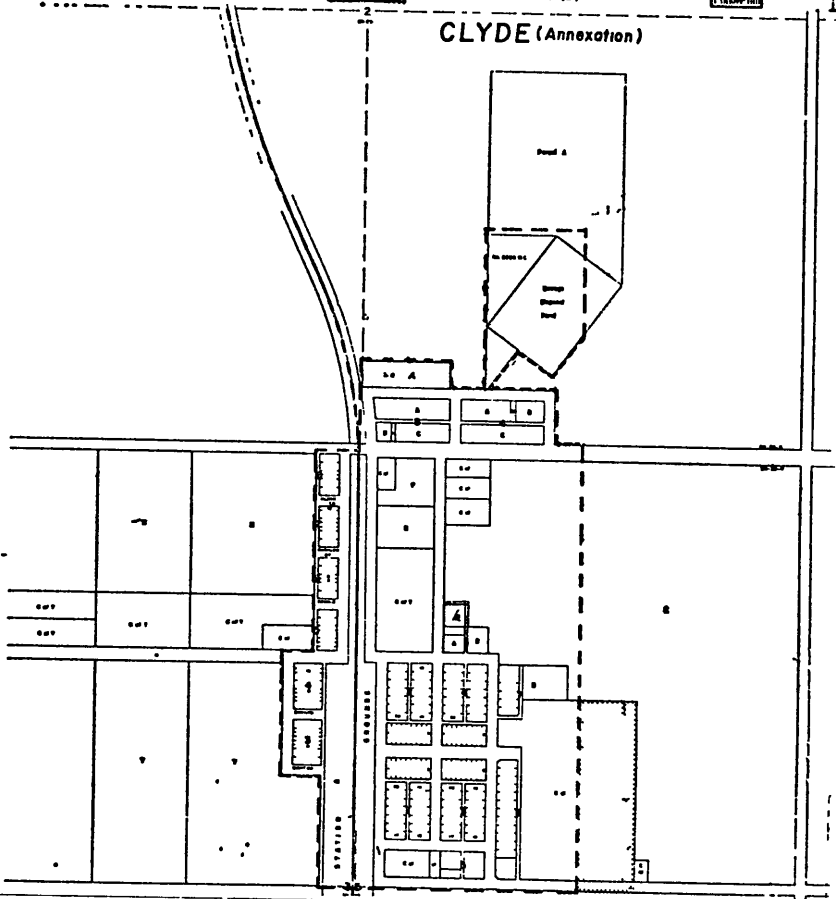

(Showing the detailed description of the lands that are annexed to the Village of Clyde, Alberta and are thereupon separated from the Municipal District of Westlock No 92)

Firstly All of the unsubdivided portion of the north-east quarter of section 35, township 59, range 25, west of the fourth meridian in the said Province not presently lying within the limits of the Village of Clyde which lies to the south and west of Parcel E as shown on filed Plan 2271 E T

Secondly All that portion of the unnamed street adjoining the south boundary of the north-east quarter of section 35, township 59, range 25, west of the fourth meridian in the said Province as shown on Sub-division Plan 1453 A J not presently lying within the limits of the Village of Clyde, which lies west of a line drawn at right angles to the north limit of the said street through a point thereon nine hundred and sixty-six and seven-tenths (966 7) feet westerly from the intersection of the said north limit with the east boundary of the said quarter section
