## ORGANIZATION OF THE VILLAGE OF DERWENT

Notice is hereby given, in accordance with the provisions of The Village Act in that behalf, that, by order of the Minister of Municipal Affairs, dated the twenty-fifth day of June, 1930, the following area, namely:

Commencing at a point on the north boundary of the north-west quarter of Section 10, in Township 54, Range 7, west of the Fourth Meridian, 200 feet east from the north-west corner of the said quarter section; thence west along the said north boundary and also along the north boundary of the north-east quarter of Section 9, Township 54, Range 7, west of the Fourth Meridian, to the intersection with the south-westerly boundary of First Avenue, as shown upon a plan of subdivision of Derwent of record in the Land Titles Office at Edmonton for the North Alberta Land Registration District, as Plan No. 420 E.O.; thence south-easterly along the said south-westerly boundary to an angle in the said First Avenue; thence continuing south-easterly along the south-westerly boundary of the said First Avenue to a point 160 feet perpendicularly distant north-westerly from the northwesterly boundary of the lane in Block 1, as shown upon the said Plan No. 420 E.O.; thence south-westerly and parallel to the northwesterly boundary of the said lane to the intersection with the northeasterly boundary of Railway Avenue, as shown upon the said Plan No. 420 E.O.; thence north-westerly along the said north-easterly boundary of Railway Avenue and the production thereof in a straight line, a distance of 1,250 feet; thence south-westerly and perpendicular to the last described course to the intersection with the south-westerly boundary of the station grounds of the Cutknife-Whitford Lake Branch of the Canadian Pacific Railway as shown upon Railway Plan No. 437 E O., of record in the said Land Titles Office; thence southeasterly along the said south-westerly boundary of the station grounds to the intersection with the east boundary of the aforesaid northeast quarter of Section 9; thence north along the said east boundary to the intersection with the production north-westerly in a straight line of the north-easterly boundary of the right-of-way of the said Cutknife-Whitford Lake Branch, as shown upon the said Plan No 437 E.O.; thence south-easterly along the production in a straight line of the north-easterly boundary of the said right-of-way, and also along the north-easterly boundary of the said right-of-way to the intersection with a line drawn parallel to the west boundary of the aforesaid north-west quarter of Section 10, from the point of commencement; thence north and along the said line to the point of commencement---

was withdrawn from the Municipal District of Ukrainia No. 513 and erected into a Village, to be known by the name of the "Village of Derwent."
