THE TOWN AND VILLAGE ACT, 1934 Gazette April 14, 1938

VILLAGE OF HEISLER DISSOLVED AND REVERTED TO THE STATUS OF A HAMLET

Edmonton, Tuesday, March 29, 1938.

Whereas a plebiscite of the proprietary electors of the Village of Heisler was taken on March 4th, 1938, as to whether they desired the Village of Heisler to continue as a Village, or whether the Village should be disorganized and reverted to the status of a Hamlet, and

Whereas nineteen voted in favour of dissolving the Village, with only three opposed; and

Whereas the Council of the Village of Heisler has requested that an Order issue for the dissolution of the Village, at the earliest possible date;

Therefore, His Honour the Lieutenant Governor, by and with the advice of the Executive Council, has been pleased to order (in accordance with the provisions of The Town and Village Act, being Chapter 49 of the Statutes of Alberta, 1934), that the Village of Heisler, be and is hereby dissolved, as and from the publication of its dissolution in The Alberta Gazette, and that the lands which are now situated within the boundaries of the said Village of Heisler, shall be added to and form part of the Municipal District of Melrose, No 426, and that the said lands shall be made subject to taxation under the provisions of The Municipal District Act, being Chapter 41 of the Statutes of Alberta, 1926, and all amendments thereto, commencing with the year 1938

Further, that the arrears of taxes outstanding and unpaid on the Assessment Roll of the said Village, shall be payable as taxes due the Municipal District of Melrose, No 426, in the same manner as if the said arrears of taxes had been levied by the said Municipal District, provided that the arrears of Municipal Taxes and all other Municipal Assets of the dissolved Village, be dealt with in accordance with the provisions of Section 20 of The Town and Village Act (being Chapter 49 of the Statutes of Alberta, 1934), and any surplus expended within the area of the dissolved village.

Further, that the Chief Municipal Inspector of the Department of Municipal Affairs, be and he is hereby appointed to be the person to adjust and settle the assets and liabilities of the dissolved Village, as provided by the aforesaid Section 20 of The Town and Village Act

That on, and from, the date of this Order, the Municipal District of Killam, No. 390, shall be known and designated as the Municipal District of Flagstaff, No. 390.

ERECTION OF THE MUNICIPAL DISTRICT OF KILLAM, No. 390

Pursuant to the authority vested in me by Section 19 of The Municipal District Act (being Chapter 151 of the Revised Statutes of Alberta, 1942), I do hereby order:

That the Municipal District of Flagstaff, No. 364 the Municipal District of Asquith, No. 394, the Municipal District of Wheatland, No. 395, the Municipal District of Kinsella, No. 424, and the Municipal District of Sterling, No. 425, be merged into one new Municipal District, to be known and designated as the Municipal District of Killam, No. 390, and shall, on, and after the date this Order becomes effective, comprise the following area:

All of Township 39, Ranges 10, 11, 12 and 13, lying north of the Battle River; all of Township 40, Ranges 10, 13, 14 and 15, lying north of the Battle River; all of Township 40, Ranges 11 and 12; all of Townships 41, 42, 43, 44, 45 and 46, Ranges 10, 11, 12, 13, 14 and 15; all the above described lands being west of the Fourth Meridian.

That the area included by this Order within the above described boundaries of the Municipal District of Killam, No. 390, shall be, and is divided into seven divisions, for electoral purposes, described as follows:

DIVISION No. 1: All of Township 39, Ranges 10, 11 and 12, lying north of the Battle River; all of Township 40, Range 10, lying north of the Battle River; all of Township 40, Ranges 11 and 12; all of Township 41, Ranges 10, 11 and 12; all the above described lands being west of the Fourth Meridian.

DIVISION No. 2: All of Township 39, Range 13, lying north of the Battle River; all of Township 40, Ranges 13, 14 and 15, lying north of the Battle River; all of Township 41, Ranges 13, 14 and 15; all of the south one-third of

Township 42, Ranges 13, 14 and 15; all the above described lands being west of the Fourth Meridian.

Division No. 3: All of Townships 42 and 43, Ranges 10, 11 and 12; all the above described lands being west of the Fourth Meridian.

DIVISION No. 4: All of the north two-thirds of Township 42, Ranges 13, 14 and 15; all of Township 43, Ranges 13, 14 and 15; all the above described lands being west of the Fourth Meridian.

Division No. 5: All of Townships 44, 45 and 46, Ranges 10 and 11; all the above described lands being west of the Fourth Meridian.

DIVISION No. 6: All of Townships 44, 45 and 46, Ranges 12 and 13; all the above described lands being west of the Fourth Meridian.

DIVISION No. 7: All of Townships 44, 45 and 46, Ranges 14 and 15; all the above described lands being west of the Fourth Meridian:

and that the council of the said Municipal District hereby constituted, shall consist of seven members; one councillor to be elected from each of the said divisions, and the candidate with the highest number of votes in each division shall be declared the councillor for that division.

That Tuesday, February 8th, 1944, be fixed as the date for receiving nominations for the office of councillor for each of the said divisions, and that the said nominations, and election (if any), shall be in accordance with Subsection (1), Paragraph (c), of Section 39 of the said Act.

That the place for receiving nominations for the office of councillor shall be at the office of the former Municipal District of Sterling, No. 425, at Killam.

That the person duly appointed to be the Returning Officer to conduct the said nomination and election (if any), shall at least seven clear days before nomination day, post up a notice in the form set out in the second part of Form "H" in the Schedule to The Municipal District Act, in accordance with the provisions of Sections 45 and 46 of the said Act.

That the Returning Officer shall divide the municipality into polling divisions, and name a polling place or places therefor and appoint such deputy returning officers and poll clerks as are necessary.

That if a poll is required for any division of the said Municipal District, it shall be held Tuesday, February 22nd, 1944, from 9 o'clock a.m. to 5 o'clock p.m.

That Robert Boyd Ritchie, be, and he is hereby appointed to prepare or cause to be prepared a voters' list of the said Municipal District of Killam, No. 390, in the same manner set

out in Section 28 of The Municipal District Act, and for such purpose shall have access to the assessment rolls and the voters' lists of the Municipal Districts which are in whole or in part merged by this Order, into the Municipal District of Killam, No. 390, and the said Robert Boyd Ritchie, shall in compiling or causing to be compiled said voters' list comply as far as possible with the provisions of Sections 29, 30 and 31 of The Municipal District Act, and carry out, or cause to be carried out, all the duties imposed by said Sections upon the Secretary-Treasurer of a Municipal District at the time and in the manner required of a Secretary-Treasurer.

That with respect to the date of erection, only, of the Municipal District of Killam, No. 390, this Order shall become effective on the 1st day of January, 1944.

That with respect to any other matter or thing referred to herein this Order shall become effective as of the date of the signing of the Order.

That part of Townships 40 and 41, Range 16, lying north of the Battle River; all of Townships 42, 43, 44, 45, 46 and 47, Ranges 16 and 17; that part of Township 41, Range 17; lying north of the Battle River; all of Townships 42, 43, 44, 45, 46, 47 and 48, Ranges 18 and 19; the west two-thirds of Township 41, Range 20; all of Townships 42, 43, 44, 45, 46, 47 and 48, Range 20; that part of Township 41, Range 21, north and east of a line described as follows; the east boundary of Section 31, and its projection south to its point of intersection with Buffalo Lake and thence following the south-west boundary of Buffalo Lake to its point of intersection with Township 41; all of Township 42, Range 21; that part of Township 43, Range 21, lying north and east of Red Deer Lake; all of Township 43, Range 22, lying north and east of Red Deer Lake; all of the above described lands being west of the Fourth Meridian.

That Stanley Stauffer of Kelsey be, and he is hereby appointed returning officer to conduct the said nomination and election (if any), and who shall at least seven clear days before nomination day post up a notice in the form set out in the second part of Form "H" in the Schedule to The Municipal District Act in accordance with the provisions of Sections 45 and 46 of the said Act.

That the returning officer shall divide the municipality into polling divisions and name a polling place or places therefor and appoint such deputy returning officers and poll clerks as are necessary.

That if a poll is required in any division of the said Municipal District it shall be held on Tuesday, February 22nd, 1944, from 9 o'clock a.m. to 5 o'clock p.m.

That Robert B. Ritchie, be, and he is hereby appointed to prepare or cause to be prepared a voters' list of the said Municipal District of Camrose, No. 427, in the same manner set out in Section 28 of The Municipal District Act, and for such purpose shall have access to the assessment rolls and voters' lists of the Municipal Districts which are in whole or in part merged by this Order into the Municipal District of Camrose, No. 427, and the said Robert B. Ritchie shall, in compiling or causing to be compiled said voters' list, comply as far as possible with the provisions of Sections 29, 30 and 31 of The Municipal District Act, and carry out or cause to be carried out all the duties imposed by said sections upon the Secretary-Treasurer of a Municipal District at the time and in the manner required of a Secretary-Treasurer.

That with respect to the date of erection, only, of the Municipal District of Camrose, No. 427, this Order shall become effective on the 1st day of January, 1944.

That with respect to any other matter or thing referred to herein, this Order shall become effective as of the date of the signing of the Order.
