MINISTERIAL ORDER

ERECTION OF THE VILLAGE OF NEW SAREPTA

Whereas the undersigned being satisfied that all requirements with respect to the incorporation of a Village under the provisions of The Town and Village Act, chapter 338 of the Revised Statutes of Alberta, 1955, and amendments thereto, have been substantially complied with, it is hereby ordered, that the area described hereunder, namely:

Those parts of the north-west quarter of section 34, township 49, range 22, bounded on the east and on the south by the east and south boundaries respectively of registered plan 1906 H.W., Certificate of Title No. 147-C-131 as registered in the Northern Alberta Land Titles Office;

That part of the west half of section 34, township 49, range 22, south and west of the north-east boundary of the station grounds as shown on railway plan 982 A.T and north of the south boundary of First street East as shown on registered plan No. 578 C L. and the south boundary of registered plan No. 5194 H.W.;

Those parts of the east half of section 33, township 49, range 22, registered in the Northern Alberta Land Titles Office as Plan No. 3199 E T, Plan No 3933 E T. Certificate of Title No. 102-N-154, Certificate of Title No. 170-E-172, Certificate of Title No. 149-C-131, Certificate of Title No. 78-B-124.

That part of the Government Road Allowance west of the north-west quarter of section 34, township 49, range 22, south of the projection west of the south boundary of registered plan No 1906 H.W. not already included;

All of the above described lands lying west of the fourth meridian;

Be and it is hereby withdrawn from the Municipal District of Leduc No. 75 and erected into a Village to be known as the Village of New Sarepta.

It is further ordered that a nomination meeting for the first election of a council be held between the hours of eleven o'clock in the forenoon and twelve o'clock noon on Monday, February 1st, 1960, for the purpose of receiving names of candidates for the office of councillor

It is further ordered that if an election is necessary, the polling day shall be Monday, February 15th, 1960, and that the election shall be conducted in accordance with the provisions of The Town and Village Act, chapter 338 of the Revised Statutes of Alberta, 1955, in that behalf

It is further ordered that the first meeting of the new council shall be held on Monday, February 22nd, 1960

It is further ordered that Leo Rene Maurice be and is hereby appointed Official Administrator of the Village from its erection on January 1st, 1960, to the first meeting of the new council and that he shall have full power and authority to make the necessary arrangements for the election ordered above.

This Order shall be effective as on and from the 1st day of January, 1960, except that for the purpose of Certificates of Assessment as required by section 284 and 297 of The School Act, chapter 297 of the Revised Statutes of Alberta, 1955, and section 110 of The Municipal Hospitals Act, chapter 216 of the Revised Statutes of Alberta, 1955, this Order shall be deemed to have been in effect as of the 31st day of December, 1959.
