The Lieutenant Governor in Council orders that

- (a) effective January 1, 2000, the land described in Appendix A and shown on the sketch in Appendix B is separated from the Municipal District of Taber and annexed to the Village of Barnwell,
- (b) any taxes owing to the Municipal District of Taber at the end of December 31, 1999 in respect of the annexed land are transferred to and become payable to the Village of Barnwell together with any lawful penalties and costs levied in respect of those taxes, and the Village of Barnwell upon collecting those taxes, penalties and costs must pay them to the Municipal District of Taber, and
- (c) the assessor for the Village of Barnwell must assess, for the purpose of taxation in 2000, the annexed land and the assessable improvements to it

APPENDIX A

DETAILED DESCRIPTION OF THE LANDS SEPARATED FROM THE MUNICIPAL DISTRICT OF TABER AND ANNEXED TO THE VILLAGE OF BARNWELL

ALL THAT PORTION OF THE NORTHEAST QUARTER OF SECTION 21 (TWENTY-ONE), TOWNSHIP 9 (NINE), RANGE 17 (SEVENTEEN), WEST OF THE FOURTH MERIDIAN, LYING TO THE NORTH AND WEST OF THE HIGHWAY 3 REALIGNMENT RIGHT-OF-WAY

ALL THAT PORTION OF THE ROAD ALLOWANCE LYING NORTH OF THE NORTHWEST QUARTER OF SECTION 21 (TWENTY-ONE) AND THE NORTHEAST QUARTER OF SECTION 21 (TWENTY-ONE) ALL WITHIN TOWNSHIP 9 (NINE), RANGE 17 (SEVENTEEN), WEST OF THE FOURTH MERIDIAN, AND BETWEEN THE PRESENT VILLAGE BOUNDARY AND THE NORTHWESTERLY BOUNDARY OF THE HIGHWAY 3 REALIGNMENT RIGHT-OF-WAY

ALL THAT PORTION OF THE SOUTHWEST QUARTER OF SECTION 28 (TWENTY-EIGHT), TOWNSHIP 9 (NINE), RANGE 17 (SEVENTEEN), WEST OF THE FOURTH MERIDIAN, LYING WITHIN THE FOLLOWING DESCRIBED BOUNDARIES

COMMENCING AT THE SOUTHEAST CORNER OF THE SAID QUARTER SECTION, THENCE WESTERLY ALONG THE SOUTHERN BOUNDARY THEREOF 1468 FEET, THENCE NORTHERLY PARALLEL WITH THE WESTERN BOUNDARY OF SAID QUARTER SECTION TO THE SOUTHERLY LIMIT OF FRANKLIN STREET ON PLAN BARNWELL 3105Y, THENCE EASTERLY ALONG SAID LIMIT OF FRANKLIN STREET TO THE EASTERN LIMIT OF FIRST AVENUE SHOWN ON SAID PLAN, THENCE NORTHERLY ALONG SAID LIMIT OF FIRST AVENUE TO THE SOUTH EASTERLY LIMIT

OF THE MAIN HIGHWAY ON PLAN 2553EZ, THENCE NORTHEASTLY ALONG SAID LIMIT OF SAID HIGHWAY TO THE EASTERN BOUNDARY OF SAID QUARTER SECTION, THENCE SOUTHERLY ALONG SAID EASTERN BOUNDARY TO THE POINT OF COMMENCEMENT, EXCEPTING THEREOUT THE PORTION OF PARCEL B ON PLAN 4854FM OUTLINED IN RED, AND EXCEPTING THEREOUT NO 3 HIGHWAY PLAN 7941JK, AND EXCEPTING THEREOUT PLAN 8410648 AND ROAD PLAN 8710118.
