ORDER IN COUNCIL

Approved and ordered:

Lieutenant Governor

The Lieutenant Governor in Council orders that

(a) effective July 1, 1999, the land described in Appendix A and shown on the sketch in Appendix B is separated from the Municipal District of Taber and annexed to the Village of Barnwell,

(b) despite clause (a), for the purposes of the 1999 taxation year, the annexed land and the assessable improvements to it must be assessed and taxed by the Municipal District of Taber as though the land and improvements remained in the Municipal District,

(c) despite clause (a), the taxes for the 1999 and previous taxation years in respect of the annexed land together with any lawful penalties and costs levied in respect of those taxes are payable to the Municipal District of Taber, and the Municipal District of Taber is, during 1999, responsible for collecting those taxes, penalties and costs,

(d) any taxes owing to the Municipal District of Taber at the end of December 31, 1999 in respect of the annexed land, together with any lawful penalties and costs levied in respect of those taxes are on January 1, 2000 transferred to and become payable to the Village of Barnwell, and the Village of Barnwell upon collecting those taxes, penalties or costs must pay them to the Municipal District of Taber, and

(e) the assessor for the Village of Barnwell must assess in 1999, for the purpose of taxation in 2000, the annexed land and the assessable improvements to it.

DETAILED DESCRIPTION OF THE LANDS SEPARATED FROM THE MUNICIPAL DISTRICT OF TABER AND ANNEXED TO THE VILLAGE OF BARNWELL

ALL THAT PORTION OF THE WEST ONE-HALF OF THE NORTHWEST QUARTER OF SECTION TWENTY-ONE (21), TOWNSHIP NINE (9), RANGE SEVENTEEN (17), WEST OF THE FOURTH MERIDIAN LYING NORTH OF THE HIGHWAY THREE (3) REALIGNMENT RIGHT-OF WAY

ALL THAT PORTION OF THE GOVERNMENT ROAD ALLOWANCE BETWEEN THE SOUTH END HERITAGE ROAD AND THE HIGHWAY THREE (3) REALIGNMENT RIGHT-OF-WAY WHICH IS NOT WITHIN THE VILLAGE OF BARNWELL
