In township 53, range 4, that portion of section 2 lying north and east of the north and ast boundaries of registered plan 1142 E.T. and not covered by the waters of Wabamun ake.

In township 53, range 4, that portion of the south-east quarter of section 10 included in ertificate of title 233 W 79.


In township 53, range 4, all of section 11 lying south of the south boundary of road plan 253 J.Y. and not covered by the waters of Wabamun Lake.
